

ORDINANCE NO. _____

1 AN ORDINANCE amending Section 2 of Ordinance No. 17595, passed January
 2 24, 2000, by including additional properties from which right-of-way is to be acquired for the
 3 improvement of East O Street from 52nd Street to Wedgewood Drive, and repealing Section
 4 2 of Ordinance No. 17595 as hitherto existing

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That Section 2 of Ordinance No. 17595 passed January 24, 2000 be
 7 and it hereby is amended to read as follows:

8 "Section 2. Detailed plans and specifications for the improvement of East
 9 "O" Street from 52nd Street to Wedgewood Drive shall provide for the construction of traffic
 10 signals and arterial street lighting. Potential amendments to the plan, marked as Attachment
 11 'A', and Recommendations on pages 5-6 of the East 'O' Street Resolution Meetings Report,
 12 marked as Attachment 'B', shall also be considered. The Department shall report to the
 13 Council on a periodic basis on its progress. The Department is authorized to acquire title to
 14 the right-of-way and permanent and temporary easements, by purchase if possible, or by
 15 condemnation if necessary, as needed to complete said construction from and over the
 16 following described lots and lands:

17 The remaining portion of Lots 31 and 32, ~~both Irregular Tracts~~ J.G. Miller
 18 Subdivision, and the remaining portion of Lots A, and B, and C, Burleighs Subdivision, all
 19 located in the Southeast Quarter of Section 20, Township 10 North, Range 7 East of the 6th
 20 Principal Meridian; Lots 154, 140, 121, 164, 110, 179, 180, 163, 220, 221, 166, 167, 162,
 21 256, 265, 266, 263, 262, 201, 132, 259, 260, 245, and 246, all Irregular Tracts; Lots 3 and
 22 4, Gateway Shopping Center Subdivision; Lots 2, 3, and Outlot "A", 'Q' Place, all located in
 23 the South Half of Section 21, Township 10 North, Range 7 East of the 6th Principal Meridian;

1 Lots 55, 58, 70, 73, and 72, all Irregular Tracts located in the Southwest Quarter of Section
2 22, Township 10 North, Range 7 East of the 6th Principal Meridian; Lots 1 and 2, Block 1, Lots
3 1 and 2, Block 3, Wedgewood Manor; Lot 30 Irregular Tract, and street right-of-way vacated
4 by Ordinances 9750 and 9981, all located in the Northwest Quarter of Section 27, Township
5 10 North, Range 7 East of the 6th Principal Meridian; Lots 71, 72, 55, 73, 74, 75, and 65, all
6 Irregular Tracts, Outlot "A", Block 1, Taylor Park Addition, and the parcel deeded to Lot 55
7 by the State, all located in the Northeast Quarter of Section 28, Township 10 North, Range 7
8 East of the 6th Principal Meridian; Lots 1 and 2, Block 1; Lots 1, 2, 3, 4, 5, 6, 7, 8, Block 4;
9 Lot 1, Block 6; and Lot "A"; all located in Eastmont 2nd Addition; Lots 1, 2, and 3, Block 1;
10 Lots 1, 2, 3, and 4, Block 2; Lots 1, 2, 3, and 4, Block 3; Lots 1, 2, and 3, Block 4; Block 12;
11 and Outlot "A", all located in Eastmont; and Lot 49 Irregular Tract; Lot 4, Block 15, and Lot
12 7, Block 16, ~~Eastridge~~ Eastmont Addition; all located in the Northwest Quarter of Section 28,
13 Township 10 North, Range 7 East of the 6th Principal Meridian; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9,
14 20, and 21, Block 1; Lots 1, and 2, Block 4, Casino Heights; Lots 1 and 2 Casino Heights 1st
15 Addition; the remaining portion of Lot 3, Leming's Subdivision, and, Lot 10, Randolph Acres;
16 all located in the Northeast Quarter of Section 29, Township 10 North, Range 7 East of the 6th
17 Principal Meridian; Lot 1, Block 1, and Lot 1, Block 5, Piedmont, located in the Southeast
18 Quarter of Section 29, Township 10 North, Range 7 East of the 6th Principal Meridian; and
19 Lot 1, Block 10, Eastridge Addition, located in the Southwest Quarter of Section 28, Township
20 10 North, Range 7 East of the 6th Principal Meridian; all located in the City of Lincoln,
21 Lancaster County, Nebraska;
22 and thereafter to proceed with constructions thereof."

23 Section 2. That Section 2 of Ordinance No. 17595, passed January 24, 2000,
24 as hitherto existing be and the same is hereby repealed.

25 Section 3. That this ordinance shall take effect and be in force from and after
26 its passage and publication according to law.
