Application by Mike Alesio for a Sidewalk Café permit.		Applicant desires to operate a sidewalk café on city right of way in front of Valentino's 232 N 13 th Street location.

DETAILS

<p>Reason for Legislation</p> <p>Mike Alesio has submitted an application for a sidewalk café in the public right of way on the sidewalk in front of Valentino's at 232 N 13th Street.</p>
<p>Discussion (Including Relationship to other Council Actions)</p> <p>In 1996, Council approved amendments to the City Sidewalk Café Ordinance, LMC 14.50 to encourage and facilitate the development of sidewalk cafes in the business owned areas of the City.</p> <p>Valentino's is applying for a permit to place four tables and sixteen chairs in the public right of way in front of their downtown location. They are not seeking exclusive use of the area containing the proposed sidewalk furniture; consequently this request for a sidewalk café permit does not include fencing. As this Valentino's location provides only take out service, the ordinance allows this non-fenced approach to requests for non-exclusive use of sidewalk café furniture.</p> <p>Representatives of the City Departments on the Outdoor Dining Committee - including staff from Planning, Police, Fire Prevention, Health, Public Works and Urban Development- have reviewed this application and recommend approvals as submitted and amended.</p> <p>The City's Urban Design Committee reviewed the request at their November 5th meeting and voted their approval of this application.</p>
