<p>An ordinance amending Section 9.36.100 of the LMC relating to Unlawful Possession of Firearms, by amending subsection (a) listing the offenses for which one conviction within the last ten years prohibits a person from possessing a firearm to provide that the offense of “criminal attempt” (Neb. Rev. Stat. §28-201), shall apply when the crime attempted is a felony or violation of any of the Nebraska State Statute misdemeanors listed in Section 9.36.100(a).</p>	Sponsor	Lincoln Police Department

<p>Discussion (Including Relationship to other Council Actions)</p> <p>Section 9.26.100(a) lists offenses for which a conviction in the last ten years makes it illegal for a person to possess a firearm. Prior to the last amendment to Section 9.26.100(a), criminal attempt was the last in the list of such offenses. Ord.18793 passed August 21, 2006, added numerous additional offenses to subsection (a) by inserting the additional offenses <u>after</u> the offense “criminal attempt”. However the language clarifying what type of attempted crime applied to this section “(where the crime attempted is a felony or any of the <u>above</u> Nebraska State Statute misdemeanor violations)” was not appropriately revised so as to include the new offenses.
