

RESOLUTION NO. A-_____

1 WHEREAS, the City of Lincoln through its Parks & Recreation Department is applying to
2 the Nebraska Game and Parks Commission for financial assistance from the Recreation Trails
3 Program Grant funds for the purpose of renovating the Boosalis Trail along Highway 2 from 17th
4 Street to 20th Street; and

5 WHEREAS, the total cost of the project will be \$118,900 of which the Great Plains Trails
6 Network will provide \$25,000, and the Recreation Trail Program grant request will be \$91,000,
7 and the City's cost will be \$2,900; and

8 WHEREAS, the City of Lincoln wishes to express its support for the project and its
9 willingness to commit the necessary financial resources to operate and maintain the completed
10 project in a safe and attractive manner for the public.

11 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lincoln,
12 Nebraska:

13 1. The City of Lincoln hereby expresses its support for the application being made
14 by its Parks & Recreation Department to the Nebraska Game and Parks Commission for
15 financial assistance from the Recreation Trails Program fund for the purpose of constructing
16 and renovating the project described above and known as the Boosalis Trail and its commitment
17 to the on-going maintenance of the trail.

18 2. The City of Lincoln currently has the commitment for \$2,900 or 20% local
19 matching share for the project elements that are identified on the application form and the
20 supplemental documents and will, as it becomes necessary, allocate the local funds for this
21 project.

22 3. The City of Lincoln will commit the necessary financial resources to operate and
23 maintain the completed project in a safe and attractive manner for public use.

1 4. The City of Lincoln will not discriminate against any person on the basis of race,
2 color, age, religion, handicap, sex, or national origin in the use of the proposed project acquired
3 or developed pursuant to the project proposal, and shall comply with the terms and intent of
4 Title VI of the Civil Rights Act of 1964, and any of the regulations promulgated pursuant to such
5 Act.

6 5. The City of Lincoln will comply with all rules and regulations of the Recreational
7 Trails Program, applicable Executive Orders and all state laws that govern the grant applicant
8 during the performance of the project.

9 6. The City of Lincoln will comply with the Federal disability access and use
10 standards where they can be reasonably applied, in accord with the Americans with Disabilities
11 Act of 1991.

12 7. The Mayor is hereby authorized to sign all documents necessary and required to
13 make application to acquire said grant funds.

14 8. The City Clerk is directed to transmit a certified copy of this resolution to the
15 Parks & Recreation Department for transmittal to the Nebraska Game and Parks Commission.
