

RESOLUTION NO. A-_____

1 WHEREAS, the City Council is authorized under Chapter 8.08 of the Lincoln Municipal
2 Code to establish and revise fees which the City may charge for body art establishments and
3 body art practitioners; and

4 WHEREAS, the Health Director has re-evaluated the estimated costs and available
5 resources to administer, operate, and enforce LMC Chapter 8.08 Body Art Establishments and
6 has determined that certain revisions are appropriate; and

7 WHEREAS, the Lincoln-Lancaster County Board of Health has reviewed the proposed
8 fees and recommends their adoption; and

9 WHEREAS, the proposed fees are before the City Council for its consideration and
10 approval.

11 NOW, THEREFORE, BE IT RESOLVED by the City Council of Lincoln, Nebraska:

12 Commencing on the effective date of this resolution, the schedule of costs for fees shall
13 be as follows:

14 **SCHEDULE OF COSTS FOR SEPTEMBER 1, 2014 TO AUGUST 31, 2015**

15 **8.08.060 Body Art Establishment; Permit Fees**

16 The fee for a body art establishment permit shall be as follows:

17 Body Art Establishment	Initial	Renewal
18 One (1) to five (5) stations	\$390.00 <u>\$400.00</u>	\$260.00 <u>\$270.00</u>
19 Each additional five (5) stations	\$160.00 <u>\$165.00</u>	\$120.00 <u>\$125.00</u>

20 **8.08.150 Body Art Practitioner Permit; Fees**

21 The fee for a body art practitioner permit shall be as follows:

22 Initial Fee	\$80.00 <u>\$85.00</u>
23 Renewal Fee	\$45.00

1 **Body Art Establishment or Practitioner Suspended Permit; Reinstatement Fee.**

2 Any person eligible for reinstatement as provided in Section 8.08.240, shall pay a reinstatement
3 fee of ~~\$195~~ \$200 for a body art establishment permit and ~~\$40~~ \$45 for a practitioner permit in
4 addition to any other applicable fees.

7 The fee for a body art establishment permit shall be as follows:

9	One (1) to five (5) stations	\$400.00 <u>\$410.00</u>	\$270.00 <u>\$280.00</u>
10	Each additional five (5) stations	\$165.00 <u>\$170.00</u>	\$125.00 <u>\$130.00</u>

11 **8.08.150 Body Art Practitioner Permit; Fees**

12 The fee for a body art practitioner permit shall be as follows:

13	Initial Fee	\$85.00	<u>\$90.00</u>
14	Renewal Fee	\$45.00	<u>\$50.00</u>

15 **Body Art Establishment or Practitioner Suspended Permit; Reinstatement Fee.**

16 Any person eligible for reinstatement as provided in Section 8.08.240, shall pay a reinstatement
17 fee of ~~\$200~~ \$205 for a body art establishment permit and ~~\$45~~ \$50 for a practitioner permit in
18 addition to any other applicable fees.
