**Supplemental Life and AD&D Insurance**

You can purchase Supplemental Life and AD&D Insurance in increments of \$10,000. The maximum amount you can purchase cannot be more than 5 times your annual Earnings or \$500,000. If you elect an amount that exceeds the guaranteed issue amount of the lesser of 5 times your annual Earnings or \$250,000, you will need to provide evidence of good health that is satisfactory to The Hartford before the excess can become effective.

The maximum amount you can purchase cannot be more than the lesser of \$100,000 or 50% of your Employee Voluntary/Supplemental Life Insurance coverage. If you elect an amount that exceeds the guaranteed issue amount of \$50,000, your Spouse will need to provide evidence of good health that is satisfactory to The Hartford before the excess can become effective.

### Confirmation
