

ORDINANCE NO. _____

1 AN ORDINANCE amending Chapter 10.48 of the Lincoln Municipal Code
2 relating to Bicycles by repealing Section 10.48.100, Transfer of Bicycle Ownership, to remove
3 outdated code provisions; repealing Section 10.48.120, Inspection, to remove outdated code
4 provisions; amending Section 10.48.250, Rental Agencies, and Section 10.48.280, Penalty,
5 to remove references to bicycle registration; and repealing Sections 10.48.250 and 10.48.280
6 of the Lincoln Municipal Code as hitherto existing.

7 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

8 Section 1. That Section 10.48.0100 of the Lincoln Municipal Code be and the
9 same is hereby repealed.

10 ~~**10.48.100 — Transfer of Bicycle Ownership.**~~

11 ~~It shall be the duty of every person who sells or transfers ownership of any registered~~
12 ~~bicycle to report, within five days from the date of sale or transfer, such sale or transfer by~~
13 ~~returning to the Police Department the registration certificate thereof, and the name and~~
14 ~~address of the person to whom said bicycle was sold or transferred; provided, however, the~~
15 ~~purchaser or transferee of said registered bicycle may apply to the Police Department to have~~
16 ~~such registration and the number plate, decal, or sticker transferred to the transferee upon~~
17 ~~payment of the proper fee and inspection as required by this chapter. It shall be the duty of~~
18 ~~the purchaser or transferee of said bicycle to apply for a transfer or registration thereof within~~
19 ~~five days of such sale or transfer.~~

1 Section 2. That Section 10.48.120 of the Lincoln Municipal Code be and the
2 same is hereby repealed.

3 ~~**10.48.120 Inspection.**~~

4 ~~The Police Department or persons designated by them shall inspect each bicycle
5 presented to it for registration and shall refuse to issue a registration certificate and number
6 plate or decal or sticker for any bicycle found to be in an unsafe mechanical condition or not
7 in conformity with the provisions of Section 10.48.110 of the Lincoln Municipal Code.~~

8 Section 3. That Section 10.48.250 of the Lincoln Municipal Code be amended
9 to read as follows:

10 **10.48.250 Rental Agencies.**

11 It shall be unlawful for any rental agency to offer any bicycle for rent ~~unless said~~
12 ~~bicycle shall first have been registered and the registration number plate attached thereto as~~
13 ~~hereinafter provided. Bicycles offered for rent by a rental agency shall be which is not~~
14 ~~equipped by such agency with lights and other safety equipment as is required by this title,~~
15 ~~and shall be kept or one which is not in good and safe working order.~~

16 Section 4. That Section 10.48.280 of the Lincoln Municipal be amended to read
17 as follows:

18 **10.48.280 Penalty.**

19 Any person violating any of the provisions of this chapter, or who shall fail, neglect,
20 or refuse to perform any duty imposed upon him or her, shall be deemed guilty of a
21 misdemeanor, and upon conviction thereof may, in lieu of the penalty elsewhere in this title
22 provided, ~~be adjudged and ordered to surrender the registration plate for his or her bicycle to~~

1 ~~the Police Department for a period of not to exceed six months,~~ or may be ordered to
2 surrender his or her bicycle for impounding for a period of not to exceed six months.

3 Section 5. That Sections 10.48.250 and 10.48.280 of the Lincoln Municipal
4 Code as hitherto existing be and the same are hereby repealed.

5 Section 6. That this ordinance shall take effect and be in force from and after
6 its passage and publication according to law.
