Language change to Lincoln Municipal Code #12.08.270	Febr. 1, 2001	To allow for the use of S.D.L.'s on City's four 18-hole golf courses

DETAILS

POSITIONS/RECOMMENDATIONS

<p>Reason for Legislation</p> <p>To modify language to Municipal Code No. 12.08.270 to allow for the use of Special Designated Licenses on the four City golf courses. Each golf professional holds a Nebraska State liquor license and, under State law, is allowed up to six S.D.L.'s per year. The language change would allow the golf professionals to use the S.D.L.'s to host large golf tournaments and events that have been lost to private golf courses in the county.</p>
<p>Discussion (Including Relationship to other Council Action)</p> <p>With approval to the language change, the City Golf Program could host an additional 24 events which would mean an increase in greens fees and cart rental of approximately \$100,000. All revenues from alcohol sales would go to the golf professional.</p> <p>Without this ordinance change, the City Golf Program will continue to have a disadvantage in competing for golf tournaments and events held on area golf courses.</p>
