

ORDINANCE NO. _____

1 AN ORDINANCE amending Section 10.06.120 of the Lincoln Municipal Code
2 to increase non-moving ticket fines and administrative fees for traffic violations; and repealing
3 Section 10.06.120 of the Lincoln Municipal Code as hitherto existing.

4 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

5 Section 1. That Section 10.06.120 of the Lincoln Municipal Code be amended
6 to read as follows:

7 **10.06.120 Payment of Fines and Costs.**

8 Any person accused of any of the following violations of the Lincoln Municipal Code
9 may appear before the Violations Bureau, waive arraignment and right to a hearing, and enter
10 a plea of guilty by payment of the sum indicated for those complaints as listed below:

- 11 (a) Violation of a motor vehicle parking ordinance or duly
12 established parking regulation not otherwise hereinafter
13 specified, or parking on or obstructing a fire lane in violation of
14 Title 19 of this code \$ 2.75
- 15 (b) Parking or stopping of a motor vehicle in such a manner as to
16 interfere with the lawful use of the street, street intersection or
17 sidewalk, or parking in an alley in violation of Section 10.32.150,
18 or the parking, stopping, or standing of a motor vehicle in a bus
19 stop zone, or parking near street intersections in violation of
20 Section 10.32.140, or obstructing private driveways in violation
21 of Section 10.32.110 \$ ~~7.75~~ 12.75
- 22 (c) Parking or stopping of a motor vehicle too close to a fire hydrant
23 in violation of Section 10.32.320 \$ ~~27.75~~ 32.75

- 1 (d) Parking or stopping of a motor vehicle in violation of Sections
2 10.40.030, 10.40.040, or 10.40.080 regarding prohibition of
3 parking on snow emergency routes, arterials, and bus routes . \$ ~~37.75~~ 42.75
- 4 (e) Parking of a motor vehicle in violation of Section 10.40.050
5 relating to parking on residential streets during a snow
6 emergency \$ ~~22.75~~ 27.75
- 7 (f) Violation of Section 10.32.020 relating to handicapped parking:
8 First offense within a one-year period \$ ~~97.75~~ 92.75
9 Second offense within a one-year period \$ ~~197.75~~ 192.75
10 Third or subsequent offense within a one-year period . . . \$ ~~297.75~~ 292.75
- 11 (g) Failure to have motor vehicle equipped with muffler in
12 good working condition as required by Section 10.22.090 . . . \$ ~~5.75~~ 7.75
- 13 (h) Failure to carry registration certificate as required by Section
14 10.08.010 \$ ~~4.75~~ 2.75
- 15 (i) Failure to have motor vehicle registered and displaying proper
16 plates (other than violations subject to the penalty set forth in
17 Section 10.08.050) \$ ~~23.75~~ 92.75
- 18 (j) Parking a motor vehicle in violation of Section 10.32.070 relating
19 to parking of trucks and other oversized vehicles on streets
20 adjacent to residentially zoned property \$ ~~27.75~~ 32.75

21 In each instance of such waiver of arraignment and right to a hearing and entry of a
22 plea of guilty, the person charged in the complaint shall pay, in addition to the amount
23 specified above, the administrative costs of ~~two~~ seven dollars and twenty-five cents (\$7.25).

24 Section 2. That Section 10.06.120 of the Lincoln Municipal Code as hitherto
25 existing be and the same is hereby repealed.

1 Section 3. That this ordinance shall take effect and be in force from and after
2 its passage and publication according to law.
