
This letter is a follow-up to our telephone conversation of December 16, 2003, in which I advised you that our client, Richard Kim, and Kabuki Japanese Restaurant, Inc. would like to amend their liquor license application to disclose two misdemeanor charges against Mr. Kim:

- (1) In December 2002, Mr. Kim pleaded guilty to an open burning violation and paid a fine of \$150.
- (2) In August 2000, Mr. Kim was charged with third-degree assault, and pled guilty to disturbing the peace, paying a fine of \$250.

Mr. Kim has asked our firm to convey this information to you on his behalf. Please consider this letter an amendment to his liquor license application. If you have any further questions or concerns regarding this matter, feel free to contact me or Mr. Kim directly.
