1 WHEREAS, the JoAnne Maxey Elementary School PTO has made application for  
2 a permit to conduct a lottery in the City of Lincoln pursuant to Chapter 9.32 of the Lincoln  
3 Municipal Code; and

4 WHEREAS, said application complies with all of the requirements of Section  
5 9.32.030 of the Lincoln Municipal Code.

6 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lincoln,  
7 Nebraska:

8 That, after public hearing duly had as required by Section 9.32.050 of the Lincoln  
9 Municipal Code, the City Council does hereby grant a permit to JoAnne Maxey Elementary School  
10 PTO to conduct a lottery in the City of Lincoln in accordance with the application filed by Patricia  
11 J. Bohart. The City Clerk is directed to issue a permit upon the payment by the applicant of the  
12 required fee, said permit to be valid only for the specific lotteries described in said application and  
13 only for a period of one year from the date of approval of this resolution. Said permit shall be  
14 subject to all of the conditions and requirements of Chapter 9.32 of the Lincoln Municipal Code.

15 BE IT FURTHER RESOLVED that pursuant to Section 9.32.080 of the Lincoln  
16 Municipal Code, a tax of 5% is imposed upon the gross proceeds received from the sale of raffle  
17 chances or tickets within the City of Lincoln, which tax shall be due no later than sixty (60) days  
18 after the conclusion of each raffle to be conducted hereunder, and if unpaid at that time, shall  
19 thereafter be delinquent.
