1 WHEREAS, Folsom Children's Zoo & Botanical Gardens has made application
2 for a permit to conduct a raffle in the City of Lincoln pursuant to Chapter 9.32 of the Lincoln
3 Municipal Code; and

4 WHEREAS, said application complies with all of the requirements of Section
5 9.32.030 of the Lincoln Municipal Code.

6 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of
7 Lincoln, Nebraska:

8 That, after public hearing duly had as required by Section 9.32.050 of the Lincoln
9 Municipal Code, the City Council does hereby grant a permit to Folsom Children's Zoo &
10 Botanical Gardens to conduct a raffle in the City of Lincoln in accordance with the application
11 filed by Jeanelle Lust. The City Clerk is directed to issue a permit upon the payment by the
12 applicant of the required fee, said permit to be valid only for the specific lotteries described in
13 said application and only for a period of one year from the date of approval of this resolution.
14 Said permit shall be subject to all of the conditions and requirements of Chapter 9.32 of the
15 Lincoln Municipal Code.

16 BE IT FURTHER RESOLVED that pursuant to Section 9.32.080 of the Lincoln
17 Municipal Code, a tax of 5% is imposed upon the gross proceeds received from the sale of
18 raffle chances or tickets within the City of Lincoln, which tax shall be due no later than sixty (60)
19 days after the conclusion of each raffle to be conducted hereunder, and if unpaid at that time,
20 shall thereafter be delinquent.
