

ORDINANCE NO. _____

1 AN ORDINANCE annexing and including the below described land as part of the
2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part
3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of
4 Lincoln, Nebraska established and shown thereon.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That the land legally described as follows:

7 Lot 77 I.T., Lot 86 I.T., Lot 143 I.T., Lot 144 I.T., Lot 145 I.T., and
8 the adjacent portion of South Folsom Street, all located within the
9 North Half of Section 3, Township 9 North, Range 6 East, and
10 also Lot 1, the north 150 feet of Lot 2, and the remaining portion
11 of Lot 10, Burnham Subdivision, Lots 1 and 2, Braun Addition, Lot
12 3 I.T., Lot 11 I.T., Lot 29 I.T., Lot 1 and that portion of Lot 2 lying
13 north of a line 350 feet south of the south right-of-way line of
14 South Burnham Street, Corrected Plat of Burnham 1st Addition,
15 that portion of Lot 186 I.T. lying north of a line 350 feet south of
16 the south right-of-way line of West Burnham Street; Lot 8, Block
17 2, Park Ridge Heights; and those portions of adjacent right-of-way
18 for West Calvert Street, South Folsom Street, West Stockwell
19 Street, West Burnham Street, and S.W. 9th Street, all within the
20 South Half of Section 3, Township 9 North, Range 6 East,
21 Lancaster County, Nebraska,

22 be and it hereby is annexed and included within the corporate limits of the City of Lincoln,
23 Nebraska and is hereby made a part of the City of Lincoln, Nebraska for all purposes.

24 Section 2. That the "Corporate Limits Map" attached to and made a part of
25 Ordinance No. 18208, be and it is hereby amended to extend the corporate limits boundary of
26 the City of Lincoln, Nebraska, to reflect the above extension of the corporate limits boundary of
27 the City of Lincoln. Said map amendment is shown on Attachment "A" which is attached hereto
28 and made a part hereof by reference.

29 Section 3. Pursuant to Article VII, Section 7 of the City Charter, this ordinance
30 shall be posted on the official bulletin board of the City in lieu of and in place of newspaper

1 publication with notice of passage and such posting to be given by publication one time in the
2 official newspaper by the City Clerk. This ordinance shall take effect and be in force from and
3 after its passage and publication as herein and in the City Charter provided.
