

ORDINANCE NO. \_\_\_\_\_

1           AN ORDINANCE annexing and including the below described land as part of the  
2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part  
3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of  
4 Lincoln, Nebraska established and shown thereon.

5           BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6           Section 1. That the land legally described as follows:

7           A portion of Lots 39, 47, 49 and 50, Irregular Tracts, located in the  
8 Southeast Quarter of Section 25, Township 11 North, Range 6  
9 East of the 6th P.M., Lancaster County, Nebraska, being more  
10 particularly described as follows:

11           Beginning at the southeast corner of said Lot 47 Irregular Tract,  
12 also being on the west right-of-way line of North 27th Street, also  
13 being the northeast corner of Lot 2, Block 5, Stone Bridge Creek  
14 Addition; thence on the north line of said Lot 2, north 89 degrees  
15 31 minutes 36 seconds west, 1085.32 feet; thence north 35  
16 degrees 45 minutes 02 seconds east, 419.00 feet; thence  
17 northerly on a 814.00 foot radius curve to the left, an arc length of  
18 642.41 feet (long chord bears north 13 degrees 08 minutes 30  
19 seconds east, 625.87 feet); thence south 90 degrees 00 minutes  
20 00 seconds east, 1064.73 feet to the east line of said Lot 50  
21 Irregular Tract, also being on the west right-of-way line of North  
22 27th Street; thence on said west right-of-way line, south 20  
23 degrees 55 minutes 40 seconds west, 1026 feet to the point of  
24 beginning, containing 950,537.29 square feet (21.82 acres) more  
25 or less;

26           be and they hereby are annexed and included within the corporate limits of the City of Lincoln,  
27 Nebraska and is hereby made a part of the City of Lincoln, Nebraska for all purposes.

28           Section 2. That the "Corporate Limits Map" attached to and made a part of  
29 Ordinance No. 18208, be and it is hereby amended to extend the corporate limits boundary of  
30 the City of Lincoln, Nebraska, to reflect the above extension of the corporate limits boundary of

1 the City of Lincoln. Said map amendment is shown on Attachment "A" which is attached hereto  
2 and made a part hereof by reference.

3 Section 3. Pursuant to Article VII, Section 7 of the City Charter, this ordinance  
4 shall be posted on the official bulletin board of the City in lieu of and in place of newspaper  
5 publication with notice of passage and such posting to be given by publication one time in the  
6 official newspaper by the City Clerk. This ordinance shall take effect and be in force from and  
7 after its passage and publication as herein and in the City Charter provided.
