RE: Report of Claims Against the City of Lincoln for July 1 through July 15, 2007

Dear Mayor & Council:

The following is a report of claims against the City of Lincoln which have been disposed of, or are pending, for the period of July 1 through July 15, 2007. This report will describe the claims and the dispositions or status of these claims.

DENIED CLAIMS:

Rita Helms filed a claim during the month of April, 2007, in an unspecified amount for damage allegedly incurred to property as the result of a water main break. This claim has been reviewed by this office and has been **denied**.

Holly Gotts filed a claim during the month of May, 2007, in an unspecified amount for injury allegedly incurred as the result of fall on sidewalk. This claim has been reviewed by this office and has been **denied**.

ALLOWED/SETTLED CLAIMS:

Ann Geary filed a claim during the month of January, 2007, alleging that she was struck by ice and snow from a snow plow as she was walking on sidewalk. This claim has been reviewed by this office and has been **settled** in the amount of \$2,045.00.

Karrie L. Licklitter filed a claim during the month of March, 2007, in the amount of \$223.90 for damage incurred to vehicle when it was struck by a Police vehicle. This claim has been reviewed by this office and has been **settled** in the amount of \$189.31.

Daniel J. Kohl and Michelle D. Story-Kohl filed a claim during the month of June, 2007, in the amount of \$2,834.29 for damage incurred to vehicle when struck by a Fire truck hose. This claim has been **settled** by the Risk Management Office in the amount of \$1,325.00.

Dusty Lord filed a claim during the month of July, 2007, in the amount of \$932.96 for damage incurred to vehicle when it was struck by a StarTran bus. This claim has been **settled** by the Risk Management Office in the amount of \$932.96.

PENDING CLAIMS:

Azim Ebrahim filed a claim during the month of March, 2006, in an unspecified amount for injury incurred when claimant allegedly slipped on ice at the parking lot at 427 South 10th Street. This claim has been referred to the insurance carrier for processing and is **pending**.

Arlene Brubaker filed a claim during the month of April, 2006, in an unspecified amount for alleged injury incurred while claimant was a passenger on a StarTran handivan. This claim is under review and is **pending**.

Susan Chocholousek filed a claim during the month of December, 2006, in an unspecified amount for alleged injury incurred when claimant was a passenger on a StarTran bus. This claim is under review and is **pending**.

Anisha Townsend filed a claim during the month of January, 2007, in an unspecified amount for alleged injury and damage incurred to vehicle as the result of an accident involving a StarTran bus. This claim is under review and is **pending**.

University of Nebraska-Hewit Place Galleries filed a claim during the month of February, 2007, in the amount of \$100,000-\$150,000 for alleged damage incurred when water flooded the Galleries from loose or uncapped water pipes in the Que Place Parking Garage when Lincoln firefighters responded to a car fire at the parking garage. This claim is under review and is **pending**.

Deborah Chinnow, Conservator of Jena I. Van Groningen filed a claim during the month of April, 2007, for injuries incurred when Jena was struck by a Police vehicle as she was crossing a City street. This claim is under review and is **pending**.

ESP, Inc. filed a claim during the month of May, 2007, in the amount of \$3,205.00 for expenses incurred when claimant was allegedly misdirected by the City during the installation of a sewer line which then required the reinstallation of a portion of the sewer line in order to meet the City's trunkline. This claim is under review and is **pending**.

Midwest Underground, Inc. filed a claim during the month of May, 2007, in the amount of \$46,353.20 for expenses incurred when claimant was allegedly misdirected by the City during the installation of a sewer line which then required the reinstallation of a portion of the sewer line in order to meet the City's trunkline. This claim is under review and is **pending**.

Joy Copes filed a claim during the month of May, 2007, in the amount of \$4,266.68 for damage allegedly incurred to vehicle as the result of a fallen tree limb. This claim is under review and is **pending**.

84 Lumber filed a claim during the month of May, 2007, in the amount of \$225.00 for damage allegedly incurred to sod when a snow plow got stuck in yard. This claim is under review and is **pending**.

Vincente J. Triche filed a claim during the month of May, 2007, in the amount of \$500,000 for alleged injury incurred when a Lincoln police vehicle allegedly ran over claimant's foot. This claim is under review and is **pending**.

Farmers Mutual (Claim No. A0704177/Jarod Smith, Insured) filed a subrogation claim during the month of June, 2007, in the amount of \$5,122.42 for damage incurred to insured's vehicle when struck by a fallen tree limb. This claim is under review and is **pending**.

Jamie Pickering filed a claim during the month of June, 2007, in the amount of \$6,728.45 for damage incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

Joni Thomas filed a claim during the month of June, 2007, in an unspecified amount for injury incurred while claimant was a passenger on a StarTran bus. This claim is under review and is **pending**.

Gerald McVey filed a claim during the month of June, 2007, in an unspecified amount for damage incurred to brick retaining wall when Lincoln Police were recovering stolen property from property adjacent to claimant's retaining wall. This claim is under review and is **pending**.

Charles Diers filed a claim during the month of June, 2007, in the amount of \$85.00 for plumbing expense incurred to turn water on at property that claimant recently purchased. This claim is under review and is **pending**.

Patricia L. Powell filed a claim during the month of July, 2007, for damage incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

Carol Koch filed a claim during the month of July, 2007, for injury incurred when claimant fell on sidewalk. This claim is under review and is **pending**.

Andrew Kusy filed a claim during the month of July, 2007, in the amount of \$288.90 for expense incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

Fred Matulka and Deb Matulka filed a claim during the month of July, 2007, in the amount of \$6,889.44 for damage to landscaping allegedly incurred as the result of the installation of sanitary sewer adjacent to claimants' property. This claim is under review and is **pending**.

PENDING TORT LITIGATION:

Ettamae Branstetter filed a claim during the month of July, 2005, in an unspecified amount for injury incurred when the automated door at the Eisley Library struck the claimant as she was exiting the Library causing her to fall. Claimant was a volunteer at the Library. This claim was reviewed by this office and denial of this claim was approved by the City Council on March 6, 2006. A Complaint was filed in the Lancaster County District Court on April 19, 2006. Litigation is **pending**.

Troy Stonacek and Shari Stonacek, Bradley Sheaff and Jennifer Sheaff, George Bristol and Lori Bristol filed claims during the month of July, 2005, for alleged damages incurred as the result of alleged failure to provide claimants with proper base flood elevations prior to construction of claimants' homes. These claims were withdrawn on February 3, 2006, and claimants have filed suit in the Lancaster County District Court naming Home Real Estate, Merle Jahde, LPT, Inc., Lyle Loth, and the City of Lincoln as defendants. Litigation is **pending**.

Shannon Johnson filed a claim during the month of September, 2005, in an unspecified amount for damages incurred as the result of an accident involving a Lincoln police vehicle. This claim was withdrawn by counsel for claimant on August 2, 2006, and suit was filed in the Lancaster County Court on August 3, 2006. Litigation is **pending**.

Thomas Beran and Carol Beran, husband and wife, individually, and as natural guardians and next friend of Brady Beran, filed a claim during the month of September, 2005, alleging that as a result of acts and omissions of the City, injuries that Brady Beran incurred during a high school football game were not promptly treated and that the delayed treatment caused exacerbated injuries. This claim was withdrawn by counsel for claimants on September 18, 2006, and suit was filed in the Lancaster County District Court on September 22, 2006. Litigation is **pending**.

Jeremy A. Walburn filed a claim during the month of April, 2006, in an unspecified amount for damages incurred as the result of an accident involving a street sweeper. This claim was reviewed by this office and denial of this claim was approved by the City Council on July 17, 2006. A suit was filed in the Lancaster County Court on October 26, 2006. Litigation is **pending**.

Kevin Boyce filed a claim during the month of April, 2006, in an unspecified amount for injury incurred as the result of a fall on sidewalk. This claim was reviewed by this office and denial of this claim was approved by the City Council on May 15, 2006. A suit was filed in the Lancaster County Court on November 9, 2006. Litigation is **pending**.

Michael Brainard filed a claim in the amount of \$300,000 for injury incurred as the result of an accident involving a StarTran bus. Denial of this claim was approved by the City Council on August 14, 2006. A suit was filed in the Lancaster County District Court on November 16, 2006. Litigation is **pending**.

Yaroslav Krasivsky filed suit in the Lancaster County Court on March 26, 2007, for damage incurred to vehicle as the result of an accident involving a City vehicle. Litigation is **pending**.

Distribution, Inc. filed a claim during the month of August, 2006, in the amount of \$22,154.44 for charges billed for water service and the attempted abandonment of an unused water line. This claim was reviewed by this office and denial of this claim was approved by the City Council on September 18, 2006. A suit was filed in the Lancaster County District Court on April 3, 2007. Litigation is **pending**.

Connie Fortney filed a claim during the month of July, 2006, in the amount of \$50,000 for damages incurred as the result of an accident involving a Lincoln police vehicle. This claim was reviewed by this office and denial of this claim was approved by the City Council on July 31, 2006. A suit was filed in the Lancaster County District Court on July 9, 2007. Litigation is **pending**.
