

ORDINANCE NO. _____

1 AN ORDINANCE amending Chapter 4.20 of the Lincoln Municipal Code relating
2 to the Library Board by amending Section 4.20.010 to provide that no Library Board director shall
3 serve more than one consecutive term of seven years; amending Section 4.20.040 to change the
4 content of the Library Board's annual report to the City Council and the date it shall be submitted;
5 and repealing Sections 4.20.010 and 4.20.040 of the Lincoln Municipal Code as hitherto existing.

6 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

7 Section 1. That Section 4.20.010 of the Lincoln Municipal Code be amended to read
8 as follows:

9 **4.20.010 Board of Directors; Appointment; Qualifications; Term.**

10 There shall be appointed by the City Council a Library Board of seven directors who shall
11 be residents of the City of Lincoln. The directors first appointed shall hold their office one for a
12 term of one year, one for a term of two years, one for a term of three years, one for a term of four
13 years, one for a term of five years, one for a term of six years, and one for a term of seven years from
14 the date of appointment, which shall be at the last meeting of the City Council in August, and one
15 director shall be appointed annually thereafter for a term of seven years. No director shall serve
16 more than one consecutive term of seven years. An appointment of a director to fill an unexpired
17 term shall not preclude that member from serving a subsequent term of seven years. Such directors
18 shall hold office until their successors are elected and qualified. Vacancies on said board shall be
19 filled by the City Council by appointment for the unexpired term. No director shall receive any pay
20 or compensation for any services rendered as a member of the board.

21 Section 2. That Section 4.20.040 of the Lincoln Municipal Code be amended to read
22 as follows:

1 **4.20.040 Annual Report.**

2 The Library Board shall, on or before the second Monday in ~~June~~ November of each year,
3 make a report to the City Council of the ~~condition of their trust on the first day of June of such year,~~
4 ~~showing all monies received or expended, the number of books and periodicals on hand, newspapers~~
5 ~~and current literature subscribed for or donated to the reading room, the number of books and~~
6 ~~periodicals obtained by purchase, gift, or otherwise during the year, and the number lost or missing~~
7 ~~and the number of and character of books loaned or issued with such statistics, information, and~~
8 ~~suggestions as they may deem of general interest~~ holdings, use of services, revenues, and other
9 topics of general interest for the previous fiscal year, which report shall be verified by affidavit of
10 the proper officers of said board.

11 Section 3. That Sections 4.20.010 and 4.20.040 of the Lincoln Municipal Code as
12 hitherto existing be and the same are hereby repealed.

13 Section 4. That this ordinance shall take effect and be in force from and after its
14 passage and publication in one issue of a daily or weekly newspaper of general circulation in the
15 City according to law.
