RE: Report of Claims Against the City of Lincoln for November 16 through November 30, 2010

Dear Mayor & Council:

The following is a report of claims against the City of Lincoln which have been disposed of, or are pending, for the period of November 16 through November 30, 2010. This report will describe the claims and the dispositions or status of these claims.

DENIED CLAIMS:

Connie Johnson filed a claim during the month of September, 2010, in an unspecified amount for injury allegedly incurred as the result of a trip and fall on sidewalk. This claim has been reviewed by this office and has been **denied**.

Shari Brewer filed a claim during the month of September, 2010, in the amount of \$383.08 for damage allegedly incurred to tire and rim as the result of debris on street at a construction site. This claim has been reviewed by this office and has been **denied**.

Rebecca Castens filed a claim during the month of November, 2010, in the amount of \$589.00 for damage allegedly incurred to computer while at Police Property. This claim has been reviewed by this office and has been **denied**.

Geraldine R. Draney filed a claim during the month of November, 2010, in the amount of \$482.00 for injury allegedly incurred as the result of fall on sidewalk. This claim has been reviewed by this office and has been **denied**.

ALLOWED/SETTLED CLAIMS:

Evey Lesoing filed a claim during the month of November, 2008, in the amount of \$5,045.90 for alleged injury incurred as the result of fall on sidewalk. **Blue Cross Blue Shield of Nebraska** filed notice of subrogation claim during the month of May, 2009, in the amount of \$15,754.59 for benefits paid on behalf of its insured as a result of insured's fall on sidewalk. These claims are under review and are **pending**.

Debra S. Roberts filed a claim during the month of November, 2010, in the amount of \$700.00 for damage allegedly incurred to driveway when a Parks Department vehicle drove on it. This claim is under review and is **pending**.

Carolyn Robinson filed a claim during the month of November, 2010, in an unspecified amount for alleged injury incurred while claimant was a passenger on a StarTran bus. This claim is under review and is **pending**.

Nationwide Insurance/Brandee M. Bell filed a claim during the month of November, 2010, in the amount of \$926.31 for damage incurred to vehicle as the result of an accident involving a police vehicle. This claim is under review and is **pending**.

William E. Marker filed a claim during the month of November, 2010, in the amount of \$602.07 for damage incurred to door of rental property as the result of action by Lincoln Police during the execution of a search warrant. This claim is under review and is **pending**.

Frank and Mary Beth Hulac filed a claim during the month of November, 2010, in the amount of \$987.85 for damage allegedly incurred to tires as the result of driving through tar at an unknown location. This claim is under review and is **pending**.

Luanne Warren filed a claim during the month of November, 2010, in the amount of \$6,000 for reimbursement of sewer main repair expenses. This claim is under review and is **pending**.

PENDING TORT LITIGATION:

Allstate Insurance Co. filed suit in the Lancaster County Court for damage incurred to insured's vehicle as the result of a motor vehicle accident involving a Lincoln police vehicle. Allstate's insured is Perian Patillo who filed a claim during the month of May, 2009, which claim was reviewed by this office and denial of this claim was approved by the City Council on June 15, 2009. Litigation is **pending**.

Bernadette Thiel filed a claim during the month of September, 2008, in an unspecified amount for injury incurred as the result of an accident involving a City-owned vehicle. This claim was withdrawn by counsel for claimant on March 23, 2010, and suit was filed in the Lancaster County District Court on March 24, 2010. Litigation is **pending**.

Lycebeth Loy filed a claim during the month of March, 2010, in the amount of \$1,000,000 for injury incurred when claimant was a passenger on a motorcycle that was involved in an accident. Claimant alleges that the accident occurred due to inadequate signage/markings and lighting at SW 4th and W. Amaranth. This claim was reviewed by this office and denial was approved by the City Council on June 7, 2010. Counsel for claimant filed suit in the Lancaster County District Court on July 27, 2010. Litigation is **pending**.

Debra Daharsh, as parent and next friend of Garrett A. Daharsh filed a claim in April, 2010, in the amount of \$270,224.09 for injury incurred to Garrett Deharsh on June 11, 2009, when he fell off of a merry-go-round at Irvingdale Park while attending a Parks and Recreation day camp at the Irvingdale Recreation Center. This claim was reviewed by this office and denial was approved by the Lincoln City Council on August 16, 2010. Counsel for claimant filed suit in the Lancaster County District Court on November 22, 2010. Litigation is **pending**.
