

ORDINANCE NO. _____

1 AN ORDINANCE amending Section 12.08.270 of the Lincoln Municipal Code
2 relating to alcoholic liquor in parks to allow alcohol to be served at Pinewood Bowl and in the
3 indoor premises of Pioneers Park Nature Center and Auld Pavilion under the circumstances
4 provided therein; and repealing Section 12.08.270 of the Lincoln Municipal Code as hitherto
5 existing.

6 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

7 Section 1. That Section 12.08.270 of the Lincoln Municipal Code be amended to
8 read as follows:

9 **12.08.270 Alcoholic Liquor Prohibited; Exceptions and Permit Requirements.**

10 It shall be unlawful for any person to consume or to possess any alcoholic liquor in any park;
11 provided, however, the above prohibition shall not apply to the following as they may be properly
12 licensed or permitted according to the Nebraska Liquor Control Act:

13 (a) The retail licensed premises consisting of the clubhouse area of golf courses and
14 outdoor areas of any 18-hole golf course;

15 (b) The premises of the Folsom Children's Zoo and the Lincoln Children's Museum in
16 conjunction with fundraising activities occurring when the zoo or museum are not otherwise open
17 to the public;

18 (c) The premises of Hazel Abel Park, Stransky Park, Sunken Gardens, Antelope Park
19 Rose Garden, and Pioneers Park Nature Center, in conjunction with fundraising activities sponsored
20 by and for the Parks and Recreation Department or by non-profit organizations specifically
21 organized to benefit the Parks and Recreation Department. Fundraising activities shall be allowed
22 to occur only where the premises or the area of the activity is not otherwise open to the public; ;

1 (d) The premises of Pinewood Bowl for Parks and Recreation Department sponsored
2 events; and

3 (e) The indoor premises of the Prairie Building at the Pioneers Park Nature Center, and
4 the indoor premises of Auld Pavilion in conjunction with City sponsored events or private rentals
5 when the premises are not otherwise open to the public. Private rentals shall use a licensed caterer
6 for the serving and dispensing of alcoholic liquor.

7 Section 2. That Section 12.08.270 of the Lincoln Municipal Code as hitherto existing
8 be and the same is hereby repealed.

9 Section 3. That this ordinance shall take effect and be in force from and after passage
10 and publication in one issue of a daily or weekly newspaper of general circulation in the City,
11 according to law.
