

ORDINANCE NO. _____

1 AN ORDINANCE amending Section 24.38.070 to increase the permit fees associated
2 with on-site wastewater treatment systems; and repealing Section 24.38.070 of the Lincoln
3 Municipal Code as hitherto existing.

4 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

5 Section 1. That Section 24.38.070 of the Lincoln Municipal Code be amended to
6 read as follows:

7 **24.38.070 Fees.**

8 The following fees for permits are required:

9 (a) On-site wastewater treatment system construction permit fee:

15 (d) Cleaner’s permit fee (annual) ~~\$380.00~~ \$390.00

16 This permit is issued on an annual basis, expires on
17 May 31 of each year, and is renewable on payment of
18 the annual fee and demonstrated compliance with the
19 requirements of this chapter.

20 (e) Any person who secures a registration certificate pursuant
21 to this chapter shall pay the following respective fee:

- (f) Permit Extension Fee \$ ~~95.00~~ \$100.00
- (g) Variance Fee ~~\$185.00~~ \$190.00
- (h) Reinstatement Fee ~~\$185.00~~ \$190.00
- (i) Development area review fees

A base fee and a per lot fee shall be paid for Health
Director review of any development area as follows:

- Base fee \$ ~~335.00~~ \$345.00
- Per lot fee \$ ~~25.00~~ \$ 30.00
- Maximum combined base fee and per lot fee \$~~1,100.00~~ \$1,200.00

(j) All fees are payable to the City of Lincoln and shall be credited to the Health Fund.
No fees will be refunded.

Section 2. That Section 24.38.070 of the Lincoln Municipal Code as hitherto existing
be and the same is hereby repealed.

Section 3. That this ordinance shall take effect and be in force from and after passage
and publication in one issue of a daily or weekly newspaper of general circulation in the City,
according to law.
