<p>Discussion (Including Relationship to other Council Actions) The Pershing Advisory Committee has served as a citizen's advisory committee to the Mayor and management staff of Pershing Center. In addition to their advisory capacity, they have provided an internal control function over the operation of Pershing Center and more recently Pinewood Bowl. At their monthly meetings, financial and other business operations of Pershing are reviewed in detail and the committee has an opportunity to ask whatever questions they would like to have answered. In addition, Pershing Center staff updates the committee on the success or failure of recent events, facility needs, upcoming events, trends in the entertainment business and community events and operations of arenas. The committee also serves as a public liaison with other constituent groups.
