

ORDINANCE NO. _____

1 AN ORDINANCE amending Chapter 8.20 of the Lincoln Municipal Code relating
2 to the Lincoln Food Code by amending Section 8.20.150 to increase the permit fees associated with
3 food establishments; amending Section 8.20.170 to increase the fee for reinstatement of a permit
4 associated with food service; and repealing Sections 8.20.150 and 8.20.170 of the Lincoln Municipal
5 Code as hitherto existing.

6 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

7 Section 1. That Section 8.20.150 of the Lincoln Municipal Code be amended to read
8 as follows:

9 **8.20.150 Food Establishment; Permit Fees**

10 (a) Any person who secures a food establishment permit under the Lincoln Food Code
11 shall pay the appropriate fee as follows:

- 12 (1) Food Establishment:
- 13 Food establishment -- new permit ~~\$480.00~~ \$495.00
- 14 Food establishment -- renewal ~~\$330.00~~ \$340.00
- 15 Each additional food preparation facility
- 16 (new or renewal) ~~\$150.00~~ \$155.00

- 17 (2) Mobile Food Unit:
- 18 New or renewal as additional facility ~~\$150.00~~ \$155.00

- 19 (3) Food Catering Services:
- 20 Operating as an additional food preparation facility
- 21 to an approved food establishment:
- 22 New or renewal ~~\$150.00~~ \$155.00

- 23 (4) Temporary Food Establishment:
- 24 (a) Operating for a single event not to exceed
- 25 fourteen consecutive days
- 26 Temporary food establishment ~~\$135.00~~ \$140.00
- 27 With a related food establishment ~~\$65.00~~ \$70.00
- 28 Nonprofit organization ~~\$65.00~~ \$70.00

1	(b) Operating annually for more than one single		
2	event not to exceed fourteen consecutive days		
3	Temporary food establishment	\$410.00	<u>\$420.00</u>
4	Non-Profit Organization	\$205.00	<u>\$210.00</u>
5	(c) Operating as an additional food preparation		
6	facility to an approved food establishment		
7	New or renewal	\$150.00	<u>\$155.00</u>
8	(d) Event Market:		
9	One to five vendors	\$150.00	<u>\$155.00</u>
10	Each additional five vendors	\$150.00	<u>\$155.00</u>
11	(e) Farmers' Market:		
12	Basic Fee	\$ 80.00	<u>\$85.00</u>
13	Plus: Vendor fee for each vendor selling		
14	foods other than fruits, vegetables and products		
15	permitted by the Nebraska Department		
16	of Agriculture	\$15.00	<u>\$20.00</u>

17 (b) Any person issued a new food establishment permit, other than a temporary food
18 establishment permit, after November 30 of each year shall pay 67% of the annual fee.

19 (c) Fees shall be payable to the Health Director and the Health Director shall deposit the
20 fees at the City Treasurer's Office. The City Treasurer shall credit the fees to the Health Fund.

21 Section 2. That Section 8.20.170 of the Lincoln Municipal Code be amended to read
22 as follows:

23 **8.20.170 Reinstatement Fee.**

24 Any person eligible for reinstatement as provided within the Lincoln Food Code shall pay
25 a reinstatement fee of ~~\$240.00~~ \$250.00 in addition to any other applicable fees. The Health Director
26 shall not reinstate the permit until the reinstatement fee is paid.

27 Section 3. That Sections 8.20.150 and 8.20.170 of the Lincoln Municipal Code as
28 hitherto existing be and the same are hereby repealed.

1 Section 4. That this ordinance shall take effect and be in force from and after passage
2 and publication in one issue of a daily or weekly newspaper of general circulation in the City,
3 according to law.
