RE: Report of Claims Against the City of Lincoln for October 16 through October 31, 2013

Dear Mayor & Council:

The following is a report of claims against the City of Lincoln which have been disposed of, or are pending, for the period of October 16 through October 31, 2013. This report will describe the claims and the dispositions or status of these claims.

DENIED CLAIMS:

Sue Thornton filed a claim during the month of October, 2013, in the amount of \$251.60 for damage incurred to windshield of vehicle when struck by a fallen tree branch. This claim has been reviewed by this office and has been **denied**.

Sean Jones filed a claim during the month of October, 2013, in the amount of \$98.08 for reimbursement of tow fee. This claim has been reviewed by this office and has been **denied**.

Farmers Insurance Group as subrogee of Kelli Kraft filed a subrogation claim during the month of October, 2013, in the amount of \$4,264.79 for damage incurred to insured's vehicle when it was struck by a fallen tree limb. This claim has been reviewed by this office and has been **denied**.

ALLOWED/SETTLED CLAIMS:

Continental Western Group, as subrogee of Insured, BGNE, Inc. filed a subrogation claim during the month of September, 2012, for worker's compensation benefits paid on behalf of Insured's employee, Travis Birkett, resulting from a motor vehicle accident involving an Animal Control vehicle. This claim has been reviewed by this office and has been **settled** in the amount of \$8,174.89.

Jeremy Hoshor filed a claim during the month of February, 2013, in the amount of \$200 for injury incurred at Belmont Recreation Center. This claim has been reviewed by this office and has been **allowed** in the amount of \$200.

Kristy and Chad Christensen filed a claim during the month of August, 2013, in the amount of \$820.85 for medical expenses incurred when claimants' son was injured while attending summer day camp at Belmont Recreation Center. This claim has been reviewed by this office and has been **allowed** in the amount of \$820.85.

Kevin Monismith filed a claim during the month of October, 2013, in the amount of \$296.83 for damage incurred to rental property as the result of action by Lincoln police executing a "no knock" warrant. This claim has been reviewed by this office and has been **allowed** in the amount of \$296.83.

Lacy Thomas filed a claim during the month of October, 2013, in the amount of \$316.72 for expense incurred when Wastewater personnel erroneously capped the service to claimant's home during a sewer main repair. This claim has been reviewed by this office and has been **allowed** in the amount of 316.72.

LITIGATION SETTLEMENT:

Krystle Park filed a claim during the month of April, 2012, in the amount of \$1,000,000 for injury incurred when claimant was bitten by a police dog. This claim was reviewed by this office and denial was approved by the Lincoln City Council on August 13, 2012. Suit was filed in the Lancaster County District Court on August 31, 2012. This case has been **settled** in the amount of \$43,805.92 with payment of \$31,740.79 to claimant and \$12,065.13 to medical providers.

PENDING CLAIMS:

Manh Van Tran filed a claim during the month of November, 2011, in the amount of \$6,252.00 for alleged damages incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

Don and Shirley Kringel filed a claim during the month of December, 2011, in an unspecified amount for alleged damages incurred as the result of a sanitary sewer back-up. This claim is under review and is **pending**.

Southern Finance, Inc. filed a claim during the month of February, 2012, in an unspecified amount for proceeds from sale of vehicle at police auction. This claim is under review and is **pending**.

These claims are under review and **pending**.

Christopher Hepburn filed a claim during the month of August, 2012, in the amount of \$200,000 for injury incurred when claimant lost control of his bicycle due to alleged unsafe condition of bike trail. This claim is under review and is **pending**.

Cynthia Gustafson filed a claim during the month of November, 2012, in the amount of \$17,000 for alleged injury incurred while claimant was a passenger on a StarTran bus. This claim is under review and is **pending**.

Gallagher Bassett Services as subrogee of United Parcel Service filed a subrogation claim during the month of February, 2013, in an unspecified amount for workers compensation benefits paid on behalf of John Sharkey who was injured as the result of a motor vehicle accident involving a StarTran handi-van. This claim was reviewed by this office and denial was approved by the Lincoln City Council on July 30, 2012. Suit was filed in the Lancaster County Court on September 10, 2012. Litigation is **pending**.

Arok Atem filed a claim during the month of March, 2012, in the amount of \$1,000,000 for injury allegedly incurred when claimant was arrested and transported to the Lancaster County Jail on April 29, 2011. This claim was withdrawn and suit was filed in the Lancaster County District Court on December 11, 2012. The case has been transferred to the U.S. District Court. Litigation is **pending**.

Clinton Brooks filed a claim during the month of August, 2012, in an unspecified amount alleging that a Lincoln police officer did not cite an individual who allegedly pushed him. This claim was reviewed by this office and denial was approved by the Lincoln City Council on August 27, 2012. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Dawn Amory filed a claim during the month of November, 2012, in the amount of \$250,000 for alleged injury incurred as the result of trip and fall on sidewalk. This claim was reviewed by this office and denial was approved by the Lincoln City Council on December 17, 2012. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Ben and Leigh Lewis on behalf of Nathan Lewis filed a claim during the month of October, 2012, in the amount of \$220,000 for injury incurred when Nathan Lewis was riding his bicycle on railroad bridge at Wilderness Park and the wheel of his bicycle got caught between two railroad ties causing him to fall. This claim was reviewed by this office and denial was approved by the Lincoln City Council on February 25, 2013. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

Angela Schmohr filed a claim during the month of July, 2012, in the amount of \$175,000 for alleged injury incurred as the result of accident involving a police vehicle. Suit was filed in the Lancaster County District Court. Litigation is **pending**.

State Farm Insurance as subrogee of Insured, David Tarrence filed a claim during the month of October, 2012, in the amount of \$17,615.65 for damage incurred to Insured's truck when it collided with an alleged low hanging tree limb. This claim was reviewed by this office and denial was approved by the Lincoln City Council on February 25, 2013. Suit was filed in the Lancaster County District Court. Litigation is **pending**.
