

## ORDINANCE NO. \_\_\_\_\_

1 AN ORDINANCE amending Section 10.02.254, “Parking Services Enforcement  
2 Area,” to include portions of the Innovation Campus area, and repealing Section 10.02.254 of the  
3 Lincoln Municipal Code as hitherto existing.

4 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

5 Section 1. That Section 10.02.254 of the Lincoln Municipal Code be amended to read  
6 as follows:

7 **10.02.254 Parking Services Enforcement Area.**

8 The Parking Services Enforcement Area shall include that portion of the city within the  
9 following bounds: from the west line of 7th Street east along the south line of H Street to the east  
10 line of 17th Street, then north along the east line of 17th Street to the south line of K Street, then east  
11 on the south line of K Street to the east line of 21st Street, then north on the east line of 21st Street  
12 to the north line of Q Street, then west on the north line of Q Street to the east line of 19th Street,  
13 then north on the east line of 19th Street to the north line of R Street, then west on the north line of  
14 R Street to the east line of 17th Street, then north on the east line of 17th Street to the north line of  
15 X Street, then west on the north line of X Street to the west line of 16th Street, then south on the west  
16 line of 16th Street to the north line of W Street, then west on the north line of W Street to the west  
17 line of 14th Street, then south on the west line of 14th Street to the north line of R Street, then west  
18 on the north line of R Street to the east line of Stadium Drive, then north on the east line of Stadium  
19 Drive to the north line of the Salt Creek Roadway, then southwesterly along the north line of the Salt  
20 Creek Roadway to the west line of Arena Drive, then south on Arena Drive to the south line of

1 N Street, then east on the south line of N Street to the west line of 7th Street, then south on the west  
2 line of 7th Street to the south line of H Street.

3 The Parking Services Enforcement Area shall also include the following, all of which are  
4 within the city boundaries: Transformation Drive east from North Antelope Valley Parkway to a  
5 point 347 feet east of the east curb line of North 21st Street on Transformation Drive; North 19th  
6 Street from Transformation Drive south to its terminus; and North 21st Street from Transformation  
7 Drive south to Salt Creek Roadway.

8 Section 2. That this ordinance shall take effect and be in force from and after passage  
9 and publication in one issue of a daily or weekly newspaper of general circulation in the City,  
10 according to law.
