WHEREAS, the parties wish to extend the agreement for an additional one (1) year term beginning **May 1, 2013 thru April 30, 2014**; and


NOW, THEREFORE, IN CONSIDERATION of the mutual covenants stated herein the parties agree as follows:







WHEREAS, the parties wish to include Attachments A & B as part of this amendment.




