



Respite Funding Resources

Respite care is temporary relief care designed to help families of adults with special needs. A caregiver often experiences stress as a result of balancing the needs of that adult with the needs of other family members. Respite care can range from a few hours of care provided on a one-time basis or overnight stays or for extended care in a facility. Respite care can be utilized on a regular or irregular basis and can be provided by family members, friends, skilled care providers or professionals.

Respite subsidy programs provide limited financial assistance to caregivers living with a person who needs continuous care and/or supervision. The caregiver is in need of respite and has secured a caregiver to provide the care.

Disabled Persons and Family Support Program

Assists with disability related expenses such as attendant care, home health care, housekeeping, special equipment, respite care, and transportation. Persons 60 years or disabled may qualify if income is less than \$1,364 per month. A couple may have up to \$1,784 per month.

Medicaid Waiver

Waiver allows Medicaid recipients age 65 and older who meet the qualifications the following services that are not usually considered "medical," i.e.: chore services, housekeeping, meal preparation, shopping, escort and supervision, adult day care, respite care, independent skills management and transportation.

Persons younger than 65 should contact the League of Human Dignity at 441-7871 for Waiver information.

VA benefits provide for a range of long-term services which include: nursing home care, domiciliary care, adult day health care, geriatric evaluation and respite care. Any veteran enrolled in health care may utilize respite care for up to 30 days in a calendar year at the Veterans Home in Grand Island or in any of the three contracted nursing homes in Lincoln (Lancaster Manor, Tabitha and Homestead) or at the Ridgewood facility in Seward.
