2.02.010 Purpose.

It is the intent and purpose of this title to establish and clarify the organization and operation of city departments and to provide for an orderly means of conducting the operations of city government and provide for the division of administrative services into departments, divisions and bureaus and define the duties and functions of each. 2.02.020 Departments of the City Designated.

The administration of the affairs of the city shall be performed under the direction and supervision of the Mayor by the following departments, each of which shall have the necessary staff and a director as designated herein:

- (a) Building and Safety - Director of Building and Safety;
- (b) Finance - Finance Director;
- (c) Fire - Fire Chief;
- (d) Health - Health Director;
- (e) Law - City Attorney;
- (f) Library - Library Director;
- (g) Parks and Recreation - Director of Parks and Recreation;
- (h) Human Resources- Human Resources Director;
- (i) Planning - Planning Director;
- (j) Police - Chief of Police;
- (k) Public Works and Utilities - Director of Public Works and Utilities;

2.02.040 Department of Building and Safety.

Under the direction and supervision of the Mayor, the Director of Building and Safety shall have charge and supervision of the Department of Building and Safety. The Director of Building and Safety shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.050 Finance Department.

Under the direction and supervision of the Mayor, the Finance Director shall have charge and supervision of the Finance Department which shall include the City Controller, City Clerk, City Treasurer, Municipal Auditorium, Budget Division, Purchasing Division, Data Processing Division, and all other offices, buildings and properties belonging to the city not otherwise assigned together with all officers, employees, accounts, records, equipment, buildings, and property, both real and personal, pertaining to said departments and officers. The Finance Director shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council, consistent with the Charter of the City of Lincoln. 2.02.060 Fire and Rescue Department.

Under the direction and supervision of the Mayor, the Fire Chief shall have charge and supervision over the Fire and Rescue Department and such divisions as the Fire Chief shall designate. The Fire Chief shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.065 Public Safety Director.

Under the direction and supervision of the Mayor, the Public Safety Director shall have charge and supervision over the Fire and Rescue Department and the Police Department. The Fire Chief and the Chief of Police shall report to and act under the supervision of the Public Safety Director. The Public Safety Director shall have such duties as provided by the ordinances of the City and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.070 Health Department.

Under the direction and supervision of the Mayor and by the terms and provisions of the interlocal agreement establishing the City-County Health Department and *Neb. Rev. Stat. §§ 71-1626 through 71-1636*, the Health Director shall have charge and supervision of the Health Department.

The Health Director shall have such duties as may be provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln, the interlocal agreement or state law including *Neb. Rev. Stat. §§ 71-1626 through 71-1636*. (Ord. 17316 §1; April 6, 1998: prior Ord. 15376 §7; January 8, 1990).

2.02.080 Law Department.

Under the direction and supervision of the Mayor and the City Council, the City Attorney shall have charge and supervision of the Law Department. The City Attorney shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.085 Library Department.

Under the direction and supervision of the Mayor and Library Board, the Library Director shall have charge and supervision of the Library Department. The Library Director shall have such duties as provided by the ordinances of the City, this code, and as may be provided by the Mayor, Library Board, or by the City Council consistent with the Charter of the City of Lincoln. 2.02.090 Parks and Recreation Department.

Under the direction and supervision of the Mayor, the Director of Parks and Recreation shall have charge and supervision of the Parks and Recreation Department which shall include all city parks, recreational activities, and city cemeteries. The Director of Parks and Recreation shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.100 Human Resources Department.

Under the direction and supervision of the Mayor, the Human Resources Director shall have charge and supervision of the personnel department, which shall be called the Human Resources Department. The Risk Management Division is assigned to, and shall be a division of, the Human Resources Department. The Human Resources Director shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.110 Planning Department.

Under the direction and supervision of the Mayor, the Planning Director shall have charge and supervision of the Planning Department. The Planning Director shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. (Ord. 15376 §11; January 8, 1990: P.C. §2.04.060: Ord. 7946 §1(part); January 14, 1963: prior Ord. 7545 §4; August 21, 1961).

2.02.120 Police Department.

Under the direction and supervision of the Mayor, the Chief of Police shall have charge and supervision over the Police Department, which shall include the Emergency Communications Center. The Chief of Police shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.130 Public Works and Utilities Department.

Under the direction and supervision of the Mayor, the Director of Public Works and Utilities shall have charge and supervision of the Department of Public Works and Utilities which shall include the following divisions, operations, and functions: City Engineering, Street Maintenance, Traffic Operations, Lincoln Water System, Lincoln Wastewater System, Solid Waste Management and Recycling Operations, Watershed Management; and all officers, employees, accounts, and records, and all plants, buildings, equipment, machinery, wells, mains, lines, and property, both real and personal, pertaining thereto. The Director of Public Works and Utilities shall also have such other and additional duties as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln. 2.02.160 Urban Development Department.

Under the direction and supervision of the Mayor and the City Council, the Urban Development Director shall have charge and supervision of the Urban Development Department. The Urban Development Director shall have such duties as provided by the ordinances of the city, this code, and as may be provided by the Mayor or by the City Council consistent with the Charter of the City of Lincoln.
