2.56.010 **Definitions.**

For purposes of this chapter, the following definitions shall apply:

Governing official shall include the Mayor or any other elected or appointed official of the City of Lincoln who has any decision-making responsibility regarding the conduct and operation of any lottery authorized or sanctioned by the City or jointly by the City with any other county, city, or village.

Immediate family shall mean and include spouse, children, grandchildren, brother, sister, parents, father-in-law, or mother-in-law.

"Connected with, interested in, or otherwise concerned directly or indirectly" shall mean the interest a person has in an organization, firm, or corporation as follows:

- (i) With respect to a sole proprietorship, an individual or his or her spouse who owns, operates, manages, or conducts, directly or indirectly, a part of the sole proprietorship;
- (ii) With respect to a partnership, an individual, or his or spouse who owns, operates, manages, or conducts, directly or indirectly, a part of the partnership activity or shares in any of the profits or potential profits of the partnership activities;
- (iii) With respect to a corporation, an individual, or his or her spouse who is an officer or director of the corporation, or who is a holder, directly or beneficially, of ten percent or more of any class of stock in the corporation. (Ord. 16330 §1; March 29, 1993).

2.56.020 **Governing Officials; Conflict of Interest; Prohibited.**

No member of the City Council of the City, or the Mayor, or any other governing official of the City, shall be connected with or interested in, directly or indirectly, any lottery operator with whom the City contracts to conduct a lottery on behalf of the City or jointly on behalf of the City and any other county, city, or village. 2.56.030 **Playing Lottery by Certain City Officials or Lottery Operator; Restrictions.**

(a) Members of the City Council of the City, the Mayor, the Finance Director of the City, and the City Controller are prohibited from playing or participating in any way in any lottery authorized or sanctioned by the City under the Nebraska County and City Lottery Act or in any joint lottery established by the City and any other county, city or village.

(b) Any lottery operator with whom the City contracts to conduct a lottery under the Nebraska County and City Lottery Act, and such operator's immediate family are prohibited from playing or participating in any way in such lottery or in any joint lottery established by the City and

any other county, city, or village. Employees and agents of any lottery operator with whom the City contracts to conduct a lottery under the Nebraska County and City Lottery Act are prohibited from playing or participating in any way in such lottery or in any joint lottery established by the City and any other county, city or village at the main location established for such lottery. The operators of any satellite location or sales outlet where such lottery is played or tickets for such lottery are purchased, and the employees and agents thereof, are prohibited from playing or participating in any way in the lottery at the satellite location or authorized sales outlet operated by such operator.
