1 AN ORDINANCE amending Chapter 27.60 of the Lincoln Municipal Code relating
2 to the Planned Unit Development District by revising the statement of intent of the Planned Unit
3 Development District; by amending Section 27.60.010 to revise the general purpose; by amending
4 Section 27.60.020 to delete existing use regulations and to add general requirements and
5 development plan requirements for planned unit developments; by renumbering Section 27.60.035
6 as 27.60.030 and amending the same to delete existing requirements regarding the form of a
7 preliminary plan and to add requirements for the form of a final planned unit development; by
8 amending Section 27.60.040 to delete existing requirements regarding preliminary plan procedures
9 and to add a process for reviewing applications for a planned unit development; by adding a new
10 section numbered 27.60.050 to provide requirements for a planned unit development following
11 approval; by repealing Section 27.60.055 regarding final plan form; by repealing Section 27.60.056
12 regarding final plan procedure; by amending Section 27.60.060 to delete the existing language
13 regarding amendment to planned unit developments and to add new requirements; by repealing
14 Section 27.60.070 regarding abandonment or failure to proceed with development of a planned unit
15 development; adding a new section numbered 27.60.080 to provide provisions regarding previously
16 approved planned unit developments; and repealing the statement of intent of Chapter 27.60 and
17 Sections 27.60.010, 27.60.020, 27.60.035, 27.60.040, and 27.60.060 of the Lincoln Municipal Code
18 as hitherto existing.

19 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

20 Section 1. That the statement of the intent of Chapter 27.60 of the Lincoln Municipal
21 Code be amended to read as follows:

1 ~~(The PUD planned unit development district is intended to permit private or public~~
2 ~~development or redevelopment of areas throughout the city which shall be substantially in~~
3 ~~accordance with goals and objectives of the comprehensive plan for the City of Lincoln. The pro-~~
4 ~~posed development shall provide a desirable environment and shall be harmonious with the general~~
5 ~~surrounding uses while permitting flexibility in overall development.)~~

6 The planned unit development district is intended to provide a mechanism to permit
7 flexibility in private or public development or redevelopment of areas throughout the city in the form
8 of an overlay zone used in combination with one or more of the city's existing zoning districts.

9 Section 2. That Section 27.60.010 of the Lincoln Municipal Code be amended to read
10 as follows:

11 **27.60.010 General Purpose.**

12 ~~The purpose of this chapter is to provide a mechanism for the approval of planned~~
13 ~~developments so as to permit private and public development or redevelopment of areas throughout~~
14 ~~the city in the form of an overlay zone intended to be used in combination with one or more of the~~
15 ~~city's existing zoning districts. Planned unit development districts are intended to promote the public~~
16 ~~convenience and necessity; protect the health, safety, and welfare, and are to be used when it is~~
17 ~~necessary or appropriate to:~~

- 18 ~~—— (a) —— Permit flexibility in the regulation of land development;~~
19 ~~—— (b) —— Encourage innovation in land use and variety in design, layout, and type of structures~~
20 ~~constructed;~~
21 ~~—— (c) —— Achieve economy and efficiency in the use of land, natural resources, energy, and the~~
22 ~~provision of public services and utilities;~~
23 ~~—— (d) —— Encourage the preservation and provision of useful open space;~~
24 ~~—— (e) —— Provide improved housing, employment, or shopping opportunities particularly suited~~

26 Planned unit development districts are intended to promote the public convenience and
27 necessity; protect the health, safety, and welfare, to implement the goals and policies of the
28 Comprehensive Plan and are to be used when it is necessary or appropriate to:

- 29 (a) Permit flexibility in the regulation of land development;
30 (b) Encourage innovation in land use, variety in design, layout, and type of construction;
31 (c) Encourage the economy and efficiency in land use, natural resources, the provision
32 of public services and utilities and the preservation of open space;

1 Section 3. That Section 27.60.020 of the Lincoln Municipal Code be amended to read

2 as follows:

3 **27.60.020 Use Regulations Requirements.**

4 ~~———— (a) ——— General Planned Unit Development. The owner or owners of any tract of land which~~
5 ~~meets the minimum acreage requirements set forth in subsection 27.60.020(a)(1) below may apply~~
6 ~~for a general planned unit development designation in any zoning district except the AG Agriculture,~~
7 ~~the AGR Agricultural Residential, or the I-3 Employment Center Districts. Use regulations of the~~
8 ~~zoning district within which the general planned unit development is proposed shall apply except~~
9 ~~as specifically modified by the approval of different or additional uses by the City Council through~~
10 ~~the adoption of a development plan as hereinafter set forth. The development plan may propose, and~~
11 ~~the City Council may approve, any permitted, conditional, or special use permitted in the R-1 Resi-~~
12 ~~dential District through the R-8 Residential District, or the B-1 Local Business District, or any~~
13 ~~permitted use, but not any permitted special use, permitted in the I-1 Industrial District, and, unless~~
14 ~~specifically modified by the city council as hereinafter set forth, the height and area, parking, and~~
15 ~~accessory use regulations applicable to such uses shall be those district regulations for districts~~
16 ~~within which such uses are permitted. If the planned unit development is located in a residential~~
17 ~~zoning district or districts, the average lot area per family within the general planned unit~~
18 ~~development shall not be less than the average lot area per family required for a community unit plan~~
19 ~~in such residential zoning district or districts. If the planned unit development is located in other~~
20 ~~than a residential zoning district, the average lot area per family shall not be less than that provided~~
21 ~~for in subsections 27.60.020(a)(2)(ii) and (a)(2)(iii). The maximum residential density of a planned~~
22 ~~unit development shall be determined in accordance with the community unit plan design standards~~
23 ~~adopted by resolution of the City Council. Planned unit developments which comply with housing~~
24 ~~for the handicapped, housing for the low income, and energy efficient housing standards adopted by~~
25 ~~resolution of the City Council may receive dwelling bonuses not to exceed a total of twenty percent~~
26 ~~(20%). Those uses which may be approved as a part of a general planned unit development that~~
27 ~~would not otherwise be permitted shall be compatible with adjacent land uses. The following con-~~
28 ~~ditions shall apply to a general planned unit development.~~

29 ~~———— (1) ——— Minimum District Size. Three acres.~~

30 ~~———— (2) ——— Use Regulations. For those land uses not otherwise permitted in the zoning~~
31 ~~districts for which the general planned unit development is proposed, the following shall apply:~~

32 ~~———— (i) ——— In residential districts:~~

33 ~~———— A. ——— In planned unit developments with a total land area of less than~~
34 ~~160 acres, not more than ten percent (10%) of the total land area in a proposed development shall~~
35 ~~be devoted to commercial uses, and not more than ten percent (10%) of the total land area in the~~
36 ~~proposed development shall be devoted to industrial land uses; provided that in no case shall the~~
37 ~~combination of such nonresidential land uses exceed fifteen percent (15%) of the total land area~~
38 ~~within the proposed development. No one commercial use shall occupy more than 5,000 square feet~~
39 ~~of floor area.~~

40 ~~———— B. ——— In planned unit developments with a total land area of 160~~
41 ~~acres or more, the maximum commercial floor area shall be one square foot of commercial floor area~~
42 ~~for every 50 square feet of total land area within the proposed development. The actual land area~~

1 devoted to commercial uses may be increased to not more than fifteen percent (15%) of the total land
2 area within the development so long as the maximum commercial floor area as determined above
3 is not exceeded. Alternately, the actual land area devoted to commercial uses may be reduced to less
4 than ten percent (10%) of the total land area within the development without reducing the maximum
5 commercial floor area so long as the ratio of commercial floor area to commercial land area is not
6 greater than one to four.

7 _____ A single commercial use may occupy up to 15,000 square feet of floor
8 area, so long as the aggregate amount of floor area exceeding 5,000 square feet for such commercial
9 use shall not exceed twenty percent (20%) of the maximum commercial floor area.

10 _____ Not more than ten percent (10%) of the total land area in the proposed
11 development shall be devoted to industrial land uses; provided, that in no case shall the combination
12 of nonresidential land uses exceed fifteen percent (15%) of the total land area within the proposed
13 development.

14 _____ C. _____ For purposes of this subsection, "total land area" shall include
15 existing public rights-of-way which abut the land included within the proposed development, up to
16 the center lines thereof. Land area "devoted to" a use not otherwise permitted in the underlying
17 zoning district shall include the actual building site, accessory parking, open space, and other land
18 directly serving or related to such a use.

19 _____ (ii) _____ In commercial districts, not more than forty percent (40%) of the total
20 land area (as defined above) in the proposed district shall be utilized for residential or industrial land
21 uses that would not otherwise be permitted. The maximum density at which residential development
22 may take place shall not exceed that which would be allowed for an equal area developed as a
23 community unit plan in an R-5 Residential District.

24 _____ (iii) _____ In industrial districts, not more than ten percent (10%) of the land area
25 may be used for residential or commercial land uses that would not otherwise be permitted. The
26 maximum density at which residential development may take place shall not exceed that which
27 would be allowed for an equal area developed as a community unit plan in an R-5 Residential
28 District.

29 _____ (iv) _____ The City Council shall require such landscaping, screening, traffic
30 access, and setbacks as are necessary to protect and enhance neighboring areas within or adjacent
31 to the planned unit development.

32 _____ (v) _____ Transfer of Zoning. Where there is more than one underlying zoning
33 district within the boundaries of a tract proposed as a general planned unit development, the council
34 may approve the transfer of permitted uses of the underlying zoning, in equal proportion of total land
35 area, to any part of the proposed tract where such transfer will promote the intent and purpose of this
36 section.

37 _____ (vi) _____ Area, Height, and Parking Requirements. The development plan shall
38 specify parking, area, and height restrictions for the project as a whole or for subareas or components
39 of the project as appropriate. The development plan shall specifically identify development pro-
40 posals which are not in conformity with applicable standards and provide evidence supporting devia-
41 tions from such standards. The City Council may impose alternate or additional standards or restric-
42 tions to achieve the intent of this ordinance. In making its determination regarding such standards
43 or restrictions, the City Council may consider the character and scale of the proposed development
44 as it relates to other uses and structures both within the district and outside the district, the general

1 character and scale of similar development within the area of the proposal, and consistency with
2 other adopted plans or standards.

3 ~~————— (b) — Corporate Office Park Planned Unit Development. The owner or owners of any tract
4 of land within the "future urban area" boundary as designated in the comprehensive plan and within
5 two miles of any community or regional multi-use center, may submit to the City Council a plan for
6 the use and development of the land for a corporate office park planned unit development. In addi-
7 tion to the conditions contained in other chapters of this title, the following conditions shall apply
8 to the corporate office park planned unit development:~~

9 ~~————— (1) — The distance between corporate office park planned unit developments,
10 measured from lot line to lot line, shall be not less than 1,000 feet.—~~

11 ~~————— (2) — Minimum Size. Ten acres.~~

12 ~~————— (3) — Maximum Total Building Floor Area Ratio (FAR). The maximum total
13 building floor area ratio for all uses in the corporate office park planned unit development shall not
14 exceed twenty-eight percent (28%) of the total land area included in the corporate office park
15 planned unit development.~~

16 ~~————— (4) — Maximum Total Building Floor Area. No corporate office park planned unit
17 development shall contain more than 200,000 square feet of the 600,000 square feet of office space
18 allocated to corporate office parks in the Comprehensive Plan. The City Council may approve, on
19 a one-to-one ratio, the transfer of all or part of the unused office space from one approved B-5
20 Community Multi-use Center to a corporate office park planned unit development located within two
21 miles of said community multi-use center. The request to transfer the unused office space from the
22 B-5 Community Multi-use Center shall be accompanied by a request from the owner of the affected
23 B-5 Community Multi-use center to amend the comprehensive plan to transfer unused designated
24 office space from the B-5 Community Multi-use Center to the corporate office park planned unit de-
25 velopment. The ordinance approving the transfer of such unused office space to the corporate office
26 park planned unit development shall be conditioned upon approval of the comprehensive plan
27 amendment. If applicable, the ordinance shall also be conditioned upon the owner of the B-5
28 Community Multi-use Center submitting a request to the Planning Director to amend an existing use
29 permit for the affected B-5 Community Multi-use Center to reduce the amount of approved office
30 space to the amount designated in the comprehensive plan as amended:~~

31 ~~————— (5) — Minimum Tenant Space. Except for buildings whose total floor area is one
32 hundred percent (100%) occupied by recreational facilities, motels and hotels, and child care centers,
33 at least fifty percent (50%) of the total floor area of any building constructed within a corporate
34 office park planned unit development shall at a minimum be occupied by the administrative offices
35 of a single association, corporation, or similar organization. The balance of space in each building
36 may be occupied by accessory uses or other permitted uses:~~

37 ~~————— (6) — Permitted Uses. The corporate office park planned unit development shall be
38 used for the administrative offices of associations, corporations, or other similar organizations,
39 general purpose office uses not frequently or regularly used or visited by the general public or offices
40 for manufacturer's agents, provided no manufacturing, handling, shipping, or exterior display of
41 merchandise shall be permitted. No other uses shall be permitted.—~~

42 ~~————— (7) — Accessory Uses. Permitted accessory uses shall be incidental to the permitted
43 uses and shall be limited to:~~

44 ~~————— (i) — Parks, playgrounds, and community buildings, owned and operated
45 by a public agency;—~~

1 ~~_____ (ii) Banks, savings and loan associations, credit unions, and finance~~
2 ~~companies;~~

3 ~~_____ (iii) Barber shops, beauty parlors, and shoeshine shops;~~

4 ~~_____ (iv) Child care centers;~~

5 ~~_____ (v) Restaurants;~~

6 ~~_____ (vi) Motels and hotels; and~~

7 ~~_____ (vii) Recreational facilities.~~

8 ~~_____ Except for motels and hotels and child care centers, accessory uses shall not exceed fifteen~~
9 ~~percent (15%) of the total building floor area contained within the corporate office park planned unit~~
10 ~~development.~~

11 ~~_____ Except for recreational facilities, motels and hotels, and child care centers, the total area~~
12 ~~occupied by an accessory use shall be located within a building whose total floor area is at least fifty~~
13 ~~percent (50%) occupied by the administrative offices of a single association, corporation, or similar~~
14 ~~organization.~~

15 ~~_____ (8) Design Standards. The corporate office park planned unit development shall~~
16 ~~comply with design standards for corporate office park planned unit developments established by~~
17 ~~resolution of the City Council.~~

18 ~~_____ (9) Parking. The corporate office park planned unit development shall provide~~
19 ~~one parking space for every 300 square feet of floor area. Parking is prohibited within the setback~~
20 ~~required by subsection 27.60.020(b)(11) below. Parking lots shall be constructed in accordance with~~
21 ~~Section 27.67.100 of the Lincoln Municipal Code.~~

22 ~~_____ (10) Street Trees. Street trees shall be provided on private property and shall~~
23 ~~comply with the design standards for street tree plantings as established by resolution of the City~~
24 ~~Council.~~

25 ~~_____ (11) Height and Area Regulations. The corporate office park planned unit~~
26 ~~development shall have a required setback of fifty feet along the entire length of the perimeter of the~~
27 ~~park. The maximum building height shall be eighty feet. However, if the building exceeds thirty~~
28 ~~feet in height, the minimum setback for the building only from any property line which abuts a~~
29 ~~residentially zoned property shall be increased by two feet for each one foot of building height over~~
30 ~~thirty feet. A property line which abuts an arterial street shall not be considered to abut residentially~~
31 ~~zoned property for purposes of this section.~~

32 ~~_____ (c) Public Facilities. The development plan for general and corporate office park planned~~
33 ~~unit developments shall specify the standards and installation schedule of necessary public facilities~~
34 ~~as required. The development plan shall address the impact and needs of the proposed development~~
35 ~~on existing and proposed street and utility systems. The City Council may impose conditions,~~
36 ~~restrictions, or standards as appropriate to achieve the intent of this ordinance, dedication of~~
37 ~~necessary rights-of-way, or easements. In making its determination regarding such conditions, re-~~
38 ~~strictions, or standards, the council may consider the adequacy of existing or adjacent facilities, the~~
39 ~~timely provision of adequate facilities, the impact of the proposed development on existing and/or~~
40 ~~planned facilities, and the overall cost to the community.~~

41 ~~_____ (d) Signs.~~

42 ~~_____ (1) General planned unit developments shall be governed by Section 27.69.340~~
43 ~~of the Lincoln Municipal Code.~~

44 ~~_____ (2) Corporate office park planned unit developments shall be governed by Section~~
45 ~~27.69.085 of the Lincoln Municipal Code.~~

1 ~~_____ (c) _____ Perimeter Treatment. Where any portion of the total land area of a land use is~~
2 ~~proposed to be adjacent to the perimeter and such land use is not permitted in the adjacent district,~~
3 ~~then the applicant must demonstrate how the proposal will mitigate any negative impacts. The City~~
4 ~~Council shall impose such other standards and requirements for perimeter treatment to protect~~
5 ~~adjoining properties from adverse effects and to achieve an appropriate transition of land uses and~~
6 ~~densities.~~

7 (a) General Requirements.

8 (1) The City or owners of any tract of land, at least three acres in size, may apply
9 for a planned unit development designation in any district except the AG Agriculture and AGR
10 Agricultural Residential districts.

11 (2) All regulations of the underlying zoning district shall apply, except as
12 provided herein and/or specifically modified by the City Council through the adoption of a
13 development plan.

14 (3) The maximum residential density of a planned unit development shall be
15 determined in accordance with the City of Lincoln Design Standards for community unit plans.
16 Planned unit developments which comply with the City of Lincoln Design Standards for Density
17 Bonuses may receive dwelling bonuses per those standards.

18 (4) Signs shall conform to Section 27.69.340, unless modified by the City
19 Council.

20 (5) All development must meet the intent and spirit of the comprehensive plan.

21 (b) Development Plan Requirements.

22 (1) The applicant shall submit a development plan for the proposed planned unit
23 development.

24 (2) The development plan may propose and the City Council may approve any
25 permitted use, conditional permitted use, or special permitted use allowed under the zoning code.

1 Notwithstanding any regulation to the contrary, a separate special permit or use permit is not
2 necessary to permit any such use.

3 (3) The development plan may propose and the City Council may approve area,
4 height, sign, parking, landscaping, screening, traffic access and setback regulations for the project
5 as a whole or for subareas or components of the project different from those within the underlying
6 zoning district. In making its determination regarding approval of such proposed standards or
7 restrictions, the City Council shall consider the character and scale of the proposed development as
8 it relates to other uses and structures both within the district and outside the district, the character
9 and scale of similar development within the area of the proposal, and consistency with other adopted
10 plans or standards. The City Council may impose alternate or additional area, height, parking,
11 landscaping, screening, traffic access, and setback regulations as necessary to protect and enhance
12 areas within or adjacent to the planned unit development and to ensure compliance with the
13 comprehensive plan and protect the health, safety, and general welfare.

14 (4) The development plan shall address the site-related impact and needs of the
15 proposed development on existing and proposed street and utility systems. The City Council may
16 impose conditions, restrictions, or standards as appropriate to achieve the intent of this ordinance,
17 and require dedication of necessary rights-of-way or easements. In making its determination
18 regarding such conditions, restrictions, or standards, the Council shall consider the adequacy of
19 existing or adjacent facilities, the timely provision of adequate facilities, the impact of the proposed
20 development on existing and/or planned facilities, and the overall cost to the community.

21 (5) Where any portion of the total land area of a land use within the planned unit
22 development is proposed to be adjacent to the perimeter of the planned unit development and such
23 land use is not permitted in the adjacent zoning district, then the development plan must address how

1 the proposal will mitigate any negative impacts. The City Council may impose additional standards
2 and requirements for perimeter treatment to protect adjoining properties from adverse effects, and
3 to achieve an appropriate transition of land uses and densities.

4 (6) For planned unit developments proposed over parcels in substantially
5 developed areas, the development plan must include appropriate standards and regulations to assure
6 that new development or renovations are in the scale and character of the existing neighborhood and
7 are sensitive to adjacent properties with respect to height, scale, use and form of the surrounding
8 neighborhood, including, but not limited to the following; land uses (including limitations on
9 allowed uses), design standards for new construction (related to the scale and character of the
10 surrounding neighborhood), height, parking, and setbacks, including both minimum and maximum
11 setbacks.

12 Section 4. That Section 27.60.030 of the Lincoln Municipal Code be and the same
13 is hereby repealed.

14 ~~**27.60.030 — Pre-application; Procedures and Requirements.**~~

15 ~~(a) The owner or owners of any tract of land proposed to be developed as a general or~~
16 ~~corporate office park planned unit development shall file a pre-application for such planned unit~~
17 ~~development designation with the Planning Director. The pre-application shall be in writing and~~
18 ~~shall include:~~

19 ~~(1) A letter of intent generally describing in narrative form the proposed~~
20 ~~development and its location, a brief discussion of the consistency or inconsistency of the proposed~~
21 ~~development with the comprehensive plan, and how the development will potentially impact the land~~
22 ~~surrounding the tracts for the proposed development and the community generally;~~

23 ~~(2) Sketch plans and land use arrangements showing proposed building types,~~
24 ~~uses and densities, traffic, and pedestrian circulation and access;~~

25 ~~(3) Preliminary proposals regarding water supply, sewerage, surface drainage, and~~
26 ~~street improvements;~~

27 ~~(4) For proposed corporate office park developments, a calculation of the building~~
28 ~~floor area ratio and calculation of the landscaped open space ratio. For purposes of this chapter,~~
29 ~~landscaped open space ratio shall mean the percent of an area devoted to and maintained for the~~
30 ~~growing of trees, shrubbery, lawns, and other plant materials, and lakes, streams, and other natural~~
31 ~~features. Said calculations to be made in conformance with the design standards for corporate office~~
32 ~~park planned unit developments.~~

1 ~~_____ (5) A request to waive the preliminary plan and reasons supporting the waiver~~
2 ~~should the developer desire to proceed directly to the final plan.~~

3 ~~_____ The Planning Director shall distribute copies of the application and all accompanying~~
4 ~~materials to other city departments and governmental agencies which are directly concerned or~~
5 ~~potentially affected by the proposed planned unit development. Within fifteen days from the filing~~
6 ~~of the pre-application, the Planning Director and representatives of those city departments and~~
7 ~~governmental agencies described above shall meet to review with the applicant the proposed planned~~
8 ~~unit development and make recommendations thereon. Within fifteen days after such meeting, the~~
9 ~~city departments and governmental agencies described above shall provide written recommendations~~
10 ~~to the Planning Director who shall, within fifteen days thereafter, prepare a written report to the~~
11 ~~applicant. Such report shall specify the Planning Director's recommendations regarding the confor-~~
12 ~~mity of the proposal to the comprehensive plan and shall recommend either approval, approval with~~
13 ~~revisions, or denial, as the case may be, and approval or denial of the request to waive the~~

18 ~~_____ (2) The existing or planned utilities and streets are adequate to serve the proposed~~

20 ~~_____ (3) The proposal is in substantial conformance with the adopted design standards~~
21 ~~of the City of Lincoln.~~

22 ~~_____ In addition to finding that the proposal meets the above criteria, the Planning Director shall~~
23 ~~consider the following in reviewing a request for a waiver of the preliminary plan:~~

32 ~~preliminary plan.~~

33 Section 5. That Section 27.60.035 of the Lincoln Municipal Code be renumbered as

38 ~~_____ (a) A statement in narrative form generally describing the proposed development and its~~
39 ~~location, statement of the present zoning of the property and the zoning of the property surrounding~~
40 ~~the tract to be included within the planned unit development, a brief discussion of the consistency~~
