

ORDINANCE NO. _____

1 AN ORDINANCE annexing and including the below described land as part of the
2 City of Lincoln, Nebraska and amending the Corporate Limits Map attached to and made a part
3 of Ordinance No. 18208, to reflect the extension of the corporate limits boundary of the City of
4 Lincoln, Nebraska established and shown thereon.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That the land legally described as follows:

7 Lots 42, 43 and 44 I.T. and the Northwest Quarter of the
8 Northeast Quarter and the vacated Union Pacific Railroad right-of-
9 way lying east of Lot 44 I.T. and all of S. 25th Street (County Road
10 No. 682) abutting thereto, all in Section 1, Township 8 North,
11 Range 6 East of the 6th P.M., Lancaster County, Nebraska;

12 and

13 Saltillo Road from the west line of said Lot 43 I.T. to the east line
14 of Section 36, Township 9 North, Range 6 East of the 6th P.M.,
15 Lancaster County, Nebraska;

16 and

17 Lots 57 and 62 I.T. and County Road No. 621 (Rokeby Road)
18 abutting thereto; that portion of Lots 1-5, 15-19, and 34 all I.T.s
19 and the Southeast Quarter of the Northwest Quarter lying east of
20 the vacated Union Pacific Railroad right-of-way; the vacated Union
21 Pacific Railroad right-of-way from the south right-of-way line of
22 Saltillo Road to the north right-of-way line of Rokeby Road, the
23 following Irregular Tracts: Lots 9-14, 21-26, 28, 32, 33, 35, 43, 44,
24 45, 80 and the Northeast Quarter of the Southeast Quarter lying
25 west of the Burlington Northern Santa Fe Railroad, all located in
26 Section 36, Township 9 North, Range 6 East of the 6th P.M.,
27 Lancaster County, Nebraska;

28 and

1 Lots 6 and 7 I.T. and that part of the BNSF Railroad abutting said
2 Lot 7 I.T., all in Section 25, Township 9 North, Range 6 East of the
3 6th P.M., Lancaster County, Nebraska;

4 be and they hereby are annexed and included within the corporate limits of the City of Lincoln,
5 Nebraska and are hereby made a part of the City of Lincoln, Nebraska for all purposes.

6 Section 2. That the "Corporate Limits Map" attached to and made a part of
7 Ordinance No. 18208, be and it is hereby amended to extend the corporate limits boundary of
8 the City of Lincoln, Nebraska, to reflect the above extension of the corporate limits boundary of
9 the City of Lincoln. Said map amendment is shown on Attachment "A" which is attached hereto
10 and made a part hereof by reference.

11 Section 3. Pursuant to Article VII, Section 7 of the City Charter, this ordinance
12 shall be posted on the official bulletin board of the City, located on the wall adjoining the City
13 Clerk's office at 555 S. 10th Street, in lieu of and in place of newspaper publication with notice
14 of passage and such posting to be given by publication one time in the official newspaper by the
15 City Clerk. This ordinance shall take effect and be in force from and after its passage and
16 publication as herein and in the City Charter provided.
