

ORDINANCE NO. \_\_\_\_\_

1 AN ORDINANCE amending Section 24.38.070 of the Lincoln Municipal Code  
2 relating to fees for On-site Wastewater Treatment Systems to incrementally increase said fees to  
3 cover costs of providing required services to business and industry and to protect the health of the  
4 residents of City; and repealing Section 24.38.070 of the Lincoln Municipal Code as hitherto  
5 existing.

6 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

7 Section 1. That Section 24.38.070 of the Lincoln Municipal Code be amended to  
8 read as follows:

9 **24.38.070 Fees.**

10 The following fees for permits are required:

- 11 (a) On-site wastewater treatment system construction permit fee:
  - 12 Standard System . . . . . \$~~345.00~~ 355.00
  - 13 Non-standard System . . . . . \$~~495.00~~ 510.00

- 14 (b) On-site wastewater treatment system repair permit fee . . . . .
- 15 \$~~190.00~~ 195.00

- 16 ~~(c) Non-standard on-site wastewater treatment system~~
- 17 ~~annual operating permit fee . . . . . \$ 70.00~~

- 18 ~~(d)~~ Cleaner’s permit fee (annual) . . . . . \$~~390.00~~ 400.00

19 This permit is issued on an annual basis, expires on  
20 May 31 of each year, and is renewable on payment  
21 of the annual fee and demonstrated compliance with  
22 the requirements of this chapter.

- 23 ~~(e)~~ Any person who secures a registration certificate pursuant  
24 to this chapter shall pay the following respective fee:

- 25 Master Installer . . . . . \$ 30.00
- 26 Journeyman Installer . . . . . \$ 30.00
- 27 Inspector . . . . . \$ 30.00

A base fee and a per lot fee shall be paid for Health Director review of any development area as follows:

9	Base fee .....	\$ <del>345.00</del> <u>355.00</u>
10	Per lot fee .....	\$ 30.00
11	Maximum combined base fee and per lot fee ..	\$1,200.00

(ji) All fees are payable to the City of Lincoln and shall be credited to the Health Fund.

No fees will be refunded.

Section 2. That Section 24.38.070 of the Lincoln Municipal Code as hitherto existing be and the same is hereby repealed.

Section 3. That this ordinance shall take effect and be in force from and after passage and publication in one issue of a daily or weekly newspaper of general circulation in the City, according to law.
