<p>The proposed resolution authorizes renaming of the park area at 7th &amp; "Q" Streets, currently known as "Iron Horse Park", as "Bill Harris Iron Horse Park" in tribute to former Mayor Bill Harris. Bill Harris served as Mayor of Lincoln between 1987 and 1991. As Mayor, he was actively involved in promoting early development of the Lincoln Historic Haymarket as a retail and entertainment district. He also served as a Nebraska State Senator from 1983 to 1987.</p> <p>The Parks &amp; Recreation Advisory Board has found naming of the park at 7th &amp; "Q" in recognition of Bill Harris to be consistent with guidelines for naming of park facilities.
