

ORDINANCE NO. \_\_\_\_\_

1 AN ORDINANCE amending Chapter 8.08 of the Lincoln Municipal Code (Body  
 2 Art Establishments) by amending Section 8.08.060 relating to permit fees for body art  
 3 establishments, Section 8.08.150 relating to permit fees for body art practitioners, and Section  
 4 8.08.350 relating to reinstatement fees to provide that the City Council may, by resolution,  
 5 establish or revise such fees; and repealing Sections 8.08.060, 8.08.150, and 8.08.350 of the  
 6 Lincoln Municipal Code as hitherto existing.

7 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

8 Section 1. That Section 8.08.060 of the Lincoln Municipal Code be amended to  
 9 read as follows:

10 **8.08.060 Body Art Establishment; Permit Fees.**

11 (a) The City Council may, by resolution, from time to time establish or revise the fees  
 12 for a body art establishment permit.

17 (b) Any initial body art establishment permit issued after December 31 and before  
 18 May 15 shall pay 67% of the initial fee. Any initial body art establishment permit issued on or  
 19 after May 15 and before July 1 shall pay the initial fee and such permit shall be valid until June

1 30 of the following year. Renewal of all body art establishment permits shall be as required in  
2 Section 8.08.080.

3 (c) The fees shall be payable to the Lincoln-Lancaster County Health Department and  
4 the Health Director shall deposit the fees at the City Treasurer's Office. The City Treasurer shall  
5 credit the fees to the Health Fund.

6 Section 2. That Section 8.08.0150 of the Lincoln Municipal Code be amended to  
7 read as follows:

8 **8.08.150 Body Art Practitioner Permit; Fees.**

9 (a) The City Council may, by resolution, from time to time establish or revise the fees  
10 for a body art practitioner permit.

11 ~~\_\_\_\_\_ The fee for a body art practitioner permit shall be as follows:~~

12 ~~\_\_\_\_\_ Initial Fee \$80.00~~

13 ~~\_\_\_\_\_ Renewal Fee \$45.00~~

14 (b) The fees shall be payable to the Lincoln-Lancaster County Health Department and  
15 the Health Director shall deposit the fees at the City Treasurer's Office. The City Treasurer shall  
16 credit the fees to the Health Fund.

17 Section 3. That Section 8.08.350 of the Lincoln Municipal Code be amended to  
18 read as follows:

19 **8.08.350 Body Art Establishment or Practitioner Suspended Permit; Reinstatement**  
20 **Fee.**

21 Any person eligible for reinstatement as provided in Section 8.08.240, shall pay a  
22 reinstatement fee of ~~\$195.00~~ as the City Council may, by resolution, from time to time establish  
23 or revise for a body art establishment ~~and \$40.00 for~~ or a practitioner permit in addition to any

1 other applicable fees. The Health Director shall not reinstate the permit until the reinstatement  
2 fee is paid.

3 Section 4. Any and all fees in effect on August 1, 2014, under the sections  
4 amended by this ordinance shall remain in effect until such time as the City Council passes a  
5 resolution establishing or revising said fees as authorized herein.

6 Section 5. That Sections 8.08.060, 8.08.150, and 8.08.350 of the Lincoln  
7 Municipal Code as hitherto existing be and the same are hereby repealed.

8 Section 6. That this ordinance shall take effect and be in force from and after  
9 passage and publication in one issue of a daily or weekly newspaper of general circulation in the  
10 City, according to law.
