

ORDINANCE NO. \_\_\_\_\_

1 AN ORDINANCE amending Section 24.38.070 of the Lincoln Municipal Code  
 2 relating to fees for onsite wastewater treatments systems to provide that the City Council may, by  
 3 resolution, establish or revise various fees related to onsite wastewater treatment systems; and  
 4 repealing Section 24.38.070 of the Lincoln Municipal Code as hitherto existing.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That Section 24.38.070 of the Lincoln Municipal Code be amended to  
 7 read as follows:

8 **24.38.070 On-Site Wastewater Treatment Facilities; Fees.**

9 ~~The following fees for permits are required:-~~

10 (a) The City Council may, by resolution, from time to time establish or revise fees for  
 11 the following:

- 12 (a1) On-site wastewater treatment system construction permit fee:
- 13 ~~Standard System . \$365.00~~
- 14 ~~Non-standard System . \$525.00~~
- 15 (b2) On-site wastewater treatment system repair permit fee ~~. \$200.00~~
- 16 (c3) Cleaner’s permit fee (annual) ~~. \$410.00~~

17 (This permit is issued on an annual basis, expires on  
 18 May 31 of each year, and is renewable on payment  
 19 of the annual fee and demonstrated compliance with  
 20 the requirements of this chapter.)

(d4) Any person who secures a registration certificate pursuant to this chapter,  
including the following shall pay the following respective fee:

Journeyman Installer \_\_\_\_\_ \$. 30.00

Inspector \_\_\_\_\_ \$. 30.00

Soil Evaluator \_\_\_\_\_ \$ 30.00

(e5) Permit Extension Fee \_\_\_\_\_ \$.105.00

(f6) Variance Fee \_\_\_\_\_ \$.200.00

(g7) Reinstatement Fee \_\_\_\_\_ \$.200.00

(h8) Development area review fees

A base fee and a per lot fee shall be paid for Health

Director review of any development area as follows:

\_\_\_\_\_ Base fee \_\_\_\_\_ \$.365.00.....

\_\_\_\_\_ Per lot fee \_\_\_\_\_ \$. .30.00.....

\_\_\_\_\_ Maximum combined base fee and per lot fee \_\_\_\_\_ \$1,235.00

(ib) All fees are payable to the ~~City of Lincoln~~ Lincoln-Lancaster County Health Department and shall be credited to the Health Fund. No fees will be refunded.

Section 2. Any and all fees in effect on August 1, 2014, under the section amended by this ordinance shall remain in effect until such time as the City Council passes a resolution establishing or revising said fees as authorized herein.

Section 3. That Section 24.38.070 of the Lincoln Municipal Code as hitherto existing be and the same are hereby repealed.

1                   Section 4. That this ordinance shall take effect and be in force from and after  
2 passage and publication in one issue of a daily or weekly newspaper of general circulation in the  
3 City, according to law.
