4 resources to administer, operate, and enforce LMC Chapter 8.14 Child Care Programs and has
5 determined that certain revisions are appropriate; and

6 WHEREAS, the Lincoln-Lancaster County Board of Health has reviewed the proposed
7 fees and recommends their adoption; and

8 WHEREAS, the proposed fees are before the City Council for its consideration and
9 approval.

10 NOW, THEREFORE, BE IT RESOLVED by the City Council of Lincoln, Nebraska:
