

ORDINANCE NO. _____

1 AN ORDINANCE amending Chapter 8.14 of the Lincoln Municipal Code relating
2 to Child Care Programs by amending Section 8.14.010 to eliminate the requirement for school-age
3 child care programs to be regulated under LMC 8.14, and repealing Section 8.14.010 of the Lincoln
4 Municipal Code as hitherto existing.

5 **8.14.010 Definitions.**

6 For the purpose of this chapter the following words shall have the following meanings:

7 **Child care program** shall mean the provision of services in lieu of parental supervision for
8 thirteen or more children under thirteen years of age for compensation either directly or indirectly,
9 on the average of less than twelve hours per day, but more than two hours per week, and shall
10 include any child care center, ~~school-age child care program~~, or preschool licensed pursuant to *Neb.*
11 *Rev. Stat.* § 71-1910, but shall not include casual care at irregular intervals, a recreation camp, any
12 program provided by the City of Lincoln Parks and Recreation Department, classes or services
13 provided by a religious organization other than child care or a preschool or nursery school, a
14 preschool program conducted in a school approved pursuant to *Neb. Rev. Stat.* § 79-318, or foster
15 care as defined in *Neb. Rev. Stat.* § 71-1901.

16 **Health Director** shall mean the Director of the Lincoln-Lancaster County Health Department
17 or authorized representative.

18 **Operator** shall mean a person, firm, partnership, company, corporation, trustee, association,
19 organization or other public or private entity, including nonprofit groups or organizations that owns,
20 operates, and manages an child care program.

21 **Parent** shall mean an adoptive or biological parent, foster parent, legal guardian, or legal
22 custodian of a minor.

23 **Person** shall mean an individual, a corporation, an organization, a limited liability company,
24 or other legal entity.

1 **Premises** shall mean the child care center or other building or facility in which a child care
2 program is operated, including areas not used for child care, all attached and all outbuildings, and
3 all areas included within the lot boundaries.

4 ~~**School-age Child Care Program** shall mean a child care program which provides before
5 or after school care for school-aged children (kindergarten and older) and is licensed pursuant to
6 *Neb. Rev. Stat. § 71-1910.*~~

7 Section 2. That Section 8.14.010 of the Lincoln Municipal Code as hitherto existing
8 be and the same is hereby repealed.

9 Section 3. That this ordinance shall take effect and be in force from and after its
10 passage and publication in one issue of a daily or weekly newspaper of general circulation in the
City, according to law.
