

ORDINANCE NO. \_\_\_\_\_

1 AN ORDINANCE vacating South 50<sup>th</sup> Street from the south line of A Street south to the  
2 north line of Everett Street and Everett Street and Washington Street from the east line of South  
3 50<sup>th</sup> Street east to the west line of South 52<sup>nd</sup> Street, and retaining title thereto in the City of Lincoln,  
4 Lancaster County, Nebraska.

5 BE IT ORDAINED by the City Council of the City of Lincoln, Nebraska:

6 Section 1. That South 50<sup>th</sup> Street from the south line of A Street south to the north line  
7 of Everett Street abutting Lot Park, Lots 1 and 15, Block 3, Lots 10 and 11, Block 4, Lots 9 and 10,  
8 Block 5, Shurtleff's Piedmont Park, Lincoln, Lancaster County, Nebraska and more particularly  
9 described on Attachment "A" which is attached hereto and made a part hereof by reference, be and  
10 the same is hereby vacated, subject to the title of said street right-of-way being vacated remaining  
11 in the City of Lincoln, Nebraska.

12 Section 2. That Everett Street from the west line of South 50<sup>th</sup> Street east to the west  
13 line of South 52<sup>nd</sup> Street abutting Lots 29 to 33, Block 3, Lots 10 to 18, Block 5, and Lots 1 and 24,  
14 Block 6, Shurtleff's Piedmont Park, Lincoln, Lancaster County, Nebraska and more particularly  
15 described on Attachment "B" which is attached hereto and made a part hereof by reference, be and  
16 the same is hereby vacated, subject to the title of said street right-of-way being vacated remaining  
17 in the City of Lincoln, Nebraska.

18 Section 3. That Washington Street from the east line of South 50<sup>th</sup> Street east to the  
19 west line of South 52<sup>nd</sup> Street abutting Lots 11 to 19, Block 4, and Lots 1 to 9, Block 5, Shurtleff's  
20 Piedmont Park, Lincoln, Lancaster County, Nebraska and more particularly described on  
21 Attachment "C" which is attached hereto and made a part hereof by reference, be and the same  
22 is hereby vacated, subject to the title of said right-of-way being vacated remaining in the City of  
23 Lincoln, Nebraska.

1           Section 4.     That, pursuant to Chapter 14.20 of the Lincoln Municipal Code, the above  
2 described vacated South 50<sup>th</sup> Street, Everett Street, and Washington Street are authorized to be  
3 conveyed to the Bryan Medical Center.

4           Section 5.     Pursuant to Article VII, Section 7 of the City Charter, this ordinance shall be  
5 posted on the official bulletin board of the City, located on the wall across from the City Clerk's  
6 office at 555 S. 10th Street, in lieu of and in place of newspaper publication with notice of passage  
7 and such posting to be given by publication one time in the official newspaper by the City Clerk.  
8 This ordinance shall take effect and be in force from and after its passage and publication as herein  
9 and in the City Charter provided.
