This letter is in response to your email of 12/16/14 requesting our quote for Ice Slicer and Near Zero, as Contract C-11-0008 ends January 1, 2015. As per our phone conversation today, we will offer the same pricing as set-out in our August 6, 2014 letter to the City of Lincoln / Lancaster County for the upcoming 2015 contract year, but we will need to review these prices in the June to July 2015 area as, if there would be a price increase, this is the time frame we will be notified by our supplier.
