



Wedding Reservation Application

SITES AND RATES Wedding sites are reserved for three (3) hours, which may be divided between two days (rehearsal and wedding). These three hours need to include time necessary for set up, clean up and taking pictures.

Stransky Park, Hamann Rose Garden, Iron Horse Park, Oak Lake Island, Veterans Memorial Garden, and Bowling Lake are each \$120.00 for three (3) hours. Sunken Gardens and Hazel Abel are \$180.00 for three (3) hours. Union Plaza Amphitheater - \$200.00 for four (4) hours. Antelope Bandshell - \$200.00 for four (4) hours. Lincoln City Golf Courses* (Ager, Highlands, Holmes, Mahoney and Pioneers) - \$100.00 for three (3) hours. (*Contact course for booking details.)

Note: Park areas are open to the general public during periods reserved for weddings and associated activities. Limited park maintenance may also occur during wedding reservation periods.

DEPOSIT Union Plaza has a \$150.00 damage deposit and all other sites require a \$100.00 damage deposit (check or cash only) fourteen days prior to wedding date. (Deposit is returned to applicant after area is inspected.)

RESERVATION PROCESS Return completed application form along with the reservation fee. *Reservation requests are processed on a first come first serve basis.* No reservations are made prior to payment being received. There will be a \$25.00 processing fee assessed to all refunds requested by the public. Lincoln City Golf Courses are booked through the individual course.
