2. PBC – Meginnis, Raybould (08.10.21)

Raybould reported the PBC held their budget hearing and had no testifiers, budget was voted on and passed. During the PBC meeting Meginnis had some question related to the project that was signed off on for the County Attorney's expansion into the new area of the Hall of Justice that is an obligation of the PBC. All the furniture, fixtures and equipment costs are charged to the specific departments. Departments may see an increase to their building rents due to security. Depending on the amount of security you have in your building departments may be paying an additional surcharge.

 Washington reported the Parks and Rec Advisory Board does not meet in August the next scheduled meeting will be in September.
- 4. Tele-Communications Advisory Board Shobe (08.12.21)
 Shobe reported representation from the three providers, Windstream, Spectrum, and Allo, were all in attendance at the meeting. Discussion was had regarding communication with the public on the rates and fees. Discussion was had regarding the franchise agreements and how this service and many of the services we use have a fee for the number of cable subscribers. Due to the rapid change in the number of subscribers the fees are changing dramatically. That discussion resulted in establishing a sub-committee to review the current contracts with each provider. The sub-committee will also look at the new expanding federal rules and regulations. The Tele-Communications Advisory Board meets quarterly so it will take some time before this information is brought back to the table.
