Dear Sirs:

We The People, men and women of the Republic for the United States of America, bring to your immediate attention and order you to cease and desist, ALL, the Genocide and Crimes against Humanity under Natural Law, Common Law, Treaty Law, Articles 6 and 7 of the International Criminal Court Statute, the Nuremberg Code, The Geneva Convention, The United Nations Convention, The United Nations Declaration on the Rights of Indigenous Peoples, in your jurisdiction.

Dear Elected Officials,

Lincoln Traffic Management continues to fail to protect the safety in my neighborhood. Here is the narrative I just submitted with my second request in UPLNK for someone to address this hazard and concern. And I ask if you would appreciate arterial traffic volume driving past your residence 24/7? Except Mr. Bowers because Touzalin is somewhat of an arterial street:

"Previously reported but apparently blown off by the Lincoln Traffic (mis)Management, the failure to sign a detour to 56th Street to discourage arterial traffic volume results in the continued safety hazard to residential neighborhood residents. You first said you don't detour short-term projects like this. Well, it's now been approximately three weeks and no end in sight so please define "short-term."

You then promised to put up 'local traffic only' signs at Fremont & 48th, as well as Adams & 50th, to discourage thru traffic, and still nothing. It's not rocket science; I saw similar signs posted in La Vista at Harrison & Plum Dale Rd. and 96th & Valley View Drive while they are working on S. 96th Street.

These are photos from 2PM. The Holland semi isn't the first and will not be the last. I'm sure he sat waiting to turn left onto Adams for quite some time. You can sit along 50th Street at 4-6PM and watch it really back up. See my neighbors at 50th & Knox and their remodeling project trailer? The Rotella's truck almost took off his mirror trying to avoid it the other day.

And if you had some common sense, somebody should have covered up the 'No Right Turn on Red' sign. You can see the sedan who needed two attempts to make the U-turn on Fremont (while the signal was red) when they realized 48th Street was closed. Kudos to the StarTran driver who had the common sense to ignore it. Why is there even a 'No Right Turn on Red' sign there? It's a straight intersection and no obstructions preventing you from seeing the traffic approaching from the south.

Congratulations for putting the 'road closed' signs back in place each day as countless people move them, especially the guy in the dark colored Chevy crew cab pickup."

Thank you for your reply.

The concept of a non-partisan commission will evaporate the next time a politically divisive change comes before the Charter Revision Commission. If the decision is along party lines favoring democrats, no matter the reasons given, the decision will be challenged as politically motivated and will become a political mess for the Mayor, the administration, and will tarnish the Charter Revision Commission. The Commission has become too important in the charter revision process to expose it to the divisive politics of the day. The solution to this is balance, political balance.

I agree that the northeast quadrant needs representation but having two appointees that live on the far east side with no other part of the quadrant represented is not a balanced geographical representation of the quadrant. Only one of these appointees should be confirmed and then only if you ignore the complete political imbalance of the Commission.

Finally, I note that you fail to address the appointment of a member that lives within easy walking distance of four other members. That appointment is in no way a geographically balanced appointment.

Thank you for writing. Like much of the rest of City government, the Charter Revision Commission is intended to be non-partisan. Accordingly, the requirements do not require a lens of political affiliation for membership – that's a good thing and City government has benefitted by being non-partisan in its deliberations.

As far as the guidance for geographical balance, two nominees live in a quadrant of the city that currently has zero representation. They will help, not hinder, efforts to keep the commission balanced geographically.
