Why can't the traffic light on Adams and 56th to turn and go south on 56th have a green turn arrow?????? I was there last night at 5:15 and traffic coming from the west on 56th was extremely long, maybe 2 to 3 blocks. There were 9 cars including me in the left turn lane. Only one person could make a turn with the stupid flashing yellow coming on first. I was the second car and when the flashing yellow came up I moved slightly out into the intersection. The light turned yellow and one car went through the light and a second car came flying down the street and ran the red light as I was trying to turn. I laid on my horn and finished my turn on a red light that held up all the people going down 56th. These lights like this tie up traffic, can lead to accidents, cause a waste of fuel, creates more pollution. If I had not been anticipating the other driver I would have been broad sided. There are green turn lights at other intersections that come on for 5 seconds which doesn't give anyone much time to turn. There are even intersections with green turn arrows with very little traffic! Does not make sense how these lights are set up around town!

The light at 84th and Olds Cheney is the same way. Why on a such a busy street like 84th is there a flashing yellow for people to turn left to go east on Old Cheney at rush hour traffic!!!!

Like I said in an email earlier this year about the traffic controls officers, if I ran for Mayor that would be my platform. I would promise to fire all the traffic software people and get someone that can program a good green turn arrow into the busy streets. I have been told a few years ago by the guy who was doing the traffic signals that "that's what the survey said as to whether a green arrow or flashing yellow was needed. I think that survey should be completely scrapped and a new one done.

Don't get me wrong the flashing yellow are find at streets with a low amount of traffic, but NOT on high traffic at rush hour which ties up traffic.

Thank you for reading this and hope as you drive the inconsistencies in the turn lights in this town.
