And I am going to learn to love having a pool in my basement. It's not water I'd want to swim in but what body of water is these days? I wish I could swim in it. It might help the full body pain I have but I might drown because I can't seem to stay awake.

Then, and this is the good part, I will used those rusted tools in my project for Lincoln. I want to make The Island of Dead Dolls look like a training stop for my yard. I go to a lot of auctions and I have done the figures. I could do it cheap. I just need to buy the lime green, light olive, mustard yellow, salmon, lilac and pepto pink paint for the

background of my painting, so to speak. The rest will be cheap, unless I find a something I can't live without. I would love to find out where the people on 35th and Q or R streets got the fat naked man statue. I would love to have 4 or 5 of them only bigger. The rest isn't planned out. I have ideas. I used to collect dolls when I wasn't so poor. I won't be able to use those dolls because they were nice. I will use the ones that usually don't sell. I can get boxes for a buck. I can get a lot of stuff that way. It will be a bargain compared to the \$20,000-\$30,000 (not including the cost to keep the alley water from getting here in the first place) it would take to fix everything the regular, boring way. The biggest cost will be paying the delivery guy. I can't do that anymore. I haven't been anywhere, but the doctor, in years. I'm not that old but my body thinks it is.
