



I saw the lease for 333 s 11th was first reading last week & will be approved next. One of the bigger neighborhood concerns has been cleanliness & maintenance. I found it oddly specific for a bathroom maintenance schedule to be included in a commercial lease like this. It is alarming to think that a potential convention center developer & city decision makers arrived at a 2 times per week cleaning as the baseline agreement for a location that services 2000 people a day. 12000 people a week. This is intentional under-resourcing & bodes poorly for the next 3 years. So I request you either strike the language altogether or require an appropriate schedule.

Also, since nothing has been done by Itu or the developer i'll mention that the fence protecting starttran riders from construction at the existing site began to pull away from the sidewalk & lean several weeks ago & continues to further deteriorate.
