Getting Started

Fill in all remaining fields on this page.

In the "Occupation Taxes" box select all tax types that apply for your business. A tax type is selected when the circle color is blue. *If Restaurant/Bar tax type applies, also select either Monthly or Quarterly for filing frequency. Only Restaurant/Bar has the Quarterly option.

Once you have verified your entries, click the "Insert" button at bottom and you will be directed to the Make a Payment screen.

Occupation Tax Payments

Filing and payment of taxes is due on or before the 25th day of the following month.

Three options are available for filing and paying Occupation Tax:

- 1) File online, which initiates an ACH payment that will be drafted from your bank account on the first business day following the 25th of the month.
- 2) Complete a printed copy of a Monthly or Quarterly Remittance Worksheet found at <u>Lincoln.ne.gov/City/Departments/Finance/City-Treasurer/Occupation-Taxes</u> and mail the form along with payment to: Lincoln City Treasurer Occupation Tax 555 South 10 St STE 103 Lincoln, NE 68508
- 3) Visit the Lincoln City Treasurer's office at the address above

**Note: You must be prepared with gross receipts information to file using any of the 3 options listed above.

Enter gross receipts and any adjustments you may have. ***When entering adjustments,** you must us a "-" negative sign if appropriate. All adjustments must be supported by entering an itemized explanation.

Click on the "Calc" button and verify the resulting calculations.



Banking Information



Enter and verify your bank routing number and account number. This is only required the first time you make an online payment. *Remember to update bank routing and account numbers if your banking information changes before filing subsequent returns.

Select the type of bank account you are using.

Read the attestation certifying the information you are providing is true and correct and check the box.

Click on the "Continue Payment" button to complete the payment.
