Note:

1) This table includes major projects during the past decade which have some unbuilt space as of the December 2002. Some other projects may have funded “impact fee” type facilities in the past, but are completely built at this point and are not included. **Each project will need a final review to confirm that they provided for eligible impact fee improvements.** Final determination will depend upon which items are deemed as eligible improvements in impact fee ordinance and further review of each agreement.

2) Residential category includes residentially zoned property such as churches and cemeteries.

3) Many exemption areas include only portions of subdivisions. See the Category Exemption map for the areas covered by exemptions.

4) The following annexation agreements were reviewed and it was determined that there were no eligible impact fee facility improvements funded. Thus, these areas are not eligible for category exemptions.
